The following taxiways at the Camarillo Airport will be closed due to a pavement maintenance to Taxiway H. The revised closure dates are as follows:

April 22, 8AM to April 27, 9AM (Phase 1, see attached)
Closed: Taxiway H (between taxiway A and B)

April 27, 9AM to April 29, 7AM (Phase 2, see attached)
Closed: Taxiways B, C, D, H

April 29, 7AM to April 30, 7AM (Phase 3, see attached)
Closed: Taxiway C (between taxiway F and H), Taxiway D (between taxiway F and H, Taxiway E, Taxiway F (west of taxiway C), Taxiway H (between taxiway D and E)

April 30, 7AM to May 1, 7AM (Phase 4, see attached)
Closed: Taxiway H (between taxiway A and B), Taxiway G (west of Taxiway G3)

All times are in local time.
Please note the schedule is subject to adjustment for project conditions.


