CommuniQuest Overview

Expertise in Facilitation

CommuniQuest has been in business 35 years working with more than 40 airports in public outreach and conflict resolution, facilitating and mediating difficult airport issues. We have facilitated working groups regarding airport noise, aviation safety, lease agreements, user letters of agreement, runway geometry, tenant-to-tenant disputes, airspace issues, systems plans, military re-use issues and land-use compatibility issues. We specialize in managing and



resolving sensitive issues with the public, users, tenants and other key stakeholders.

The firm's principle, Christine Eberhard, is uniquely qualified based not only on her extensive airport and aviation experience, but also on her continuing educational endeavors including receiving her Masters in Dispute Resolution degree from Pepperdine School of Law. Ms. Eberhard has dedicated her

Through the group's efforts a number of airspace modifications were made that enhanced the safety and efficiency of the airspace in the Los Angeles area.

Recognized as a leader in aviation conflict resolution, CommuniQuest was hired as a consultant to the FAA for a special helicopter project during the 1996 Atlanta Olympics. CommuniQuest was responsible for the community outreach including the formation and facilitation of a Steering Committee comprised of local airports and users in the Atlanta area.

In addition, CommuniQuest has written a number of manuals including a helicopter mitigation handbook for Southern California Association of Governments (SCAG), a Community Involvement Handbook for SCAG, a Community Relations Toolkit for the National Air Transportation Association (NATA) and a guide entitled "Mediating and Resolving Airport Disputes."



Approach to Project

Christine Eberhard will be the project manager for CommuniQuest (CQ), providing process development, coordination and facilitator services for the Ventura County Department of Airports and the hangar tenants in the lease update process. In addition, CommuniQuest will work with the participants to keep other stakeholders up to date as well as assisting in an outcome summary to the Board of Supervisors.



Task 1: Ad-Hoc Lease Update Committee Introductory Meeting

The project will be initiated with the formation of an Ad-Hoc Lease Update Committee (committee). CQ will assist in this process initiation with research and information gathering to establish a one-day introductory meeting of the committee. This may require telephonic meetings between key individuals and CommuniQuest to create the process, as well as during the process to effectively provide communication and facilitation of the lease update process.

In addition, CQ will provide meeting logistics services as well as staffing for the meetings, as needed and requested. CommuniQuest will assist the parties in developing ground rules and procedures for the process, including contact with the media.

Task 2: One-day Facilitated Meeting

CommuniQuest will coordinate with the committee based on the information from the introductory meeting to establish a one-day meeting of the parties to discuss and resolve the lease issues regarding the storage hangars at Camarillo and Oxnard airports. Ms. Eberhard will facilitate this one-day meeting to assist in successful resolution. The focus will be on interest-based discussion with exploration of options that will provide productive results.

Ms. Eberhard will work with the committee to help them find options and solutions to resolve the lease issues. As needed, CQ will assist the parties in resolving issues within their respective groups and assist in getting buy-in from members of their groups.

Task 3: Coordination and Follow-up

Following the one-day meeting, CommuniQuest will assist the members of the committee to report back to their respective groups and provide support with any open items that came out of the one-day meeting. CommuniQuest will assist in soliciting input from tenants on the draft lease and compile comments for consideration by the committee in follow-up meeting.

Task 4: Town Hall Meeting

CommuniQuest will assist the parties in coordinating and holding a Town Hall meeting at the Airport. The parties will present the results of the meetings and take questions from the attendees. Ms. Eberhard will facilitate the meeting and discussion, as needed.

Task 5: Participate in Formal Public Process

CommuniQuest will coordinate with members of the committee to assist them in preparation for the formal public process. CQ will also assist with any follow-up needed after the Town Hall meeting. Ms. Eberhard will attend the Aviation Advisory Commission meeting, Airport Authorities meeting, and Board of Supervisors meeting and participate as needed and requested.

ADDITIONAL EXAMPLES OF EXPERIENCE AND EXPERTISE

- Consultant to City of Redlands, California. CommuniQuest facilitated a meeting between pilots and City staff regarding helicopter procedures at the Airport. CommuniQuest flew the approach and departure paths with one of the helicopter operators to determine safety issues with existing procedures and provided a summary report to the City regarding safety implications in changing any existing routes or altitudes.
