

OAK PARK MUNICIPAL ADVISORY COUNCIL MINUTES
of official Meeting on Tuesday, November 17, 2015
The Oak Park MAC held an official meeting Tuesday, November 17, 2015 at 7:00 PM
Oak Park Library, 899 N. Kanan Road, Oak Park

1. Call to Order

The meeting was called to order by *Chair Alon Glickstein* at 7:00 PM. *Mike McReynolds*, *Robert Von Schneidau* and *Chris Chapman* were also present. *Michael Paule* was absent.

2. Flag Salute

Mike McReynolds led the flag salute.

3. Adoption of the Agenda

The agenda was adopted 4-0 on a motion by *Chris Chapman* seconded by *Robert Von Schneidau*.

4. Approval of the minutes of October 27

The minutes were approved 4-0 on a motion by *Alon Glickstein* seconded by *Chris Chapman*.

5. Public Safety reports

Ventura County Sheriff's Office Captain Ross Bonfiglio reported that in the past month of October there had been no violent crime reported, and that the overall rate of crime was extremely low. There had occurred one residential burglary involving an unlocked side door to a garage on Buttonwood, the use of a ladder found within the garage to access an open second story bedroom window, and then the theft of cash and valuable jewelry from the bedroom. Also, the Church of the Epiphany was broken into, and doors were damaged, and there was the theft of a surfboard from a vehicle on Smoketree. *Captain Bonfiglio* reported that an explosive device possibly involving chlorine was set off in Medea Creek Park on November 9 underneath a pedestrian bridge, or drainage tunnel. The Fire Department had to put out a small fire, and an arson investigator analyzed the scene, but no leads had yet been developed.

6. Comments of Ventura County Supervisor Linda Parks

Supervisor Parks was unable to attend, her assistant Jan Osterhaven did not give a report.

7. Information items

a. Oversized Vehicle Ordinance requirements for Oak Park, and construction truck staging

MAC members acknowledged knowing about a case in recent weeks involving a Kilburn tank site cell tower construction vehicle parked for 5 days on the Kilburn Ct. cul-de-sac.

8. Public comments

There were none.

9. Council comments

Mike McReynolds wished a Happy Thanksgiving to everyone.

10. Written communications

Alon Glickstein reported an e-mail about trash rates showing that Oak Park had the lowest rates in the east County, and he commented that ordering extra containers made the rates more expensive.

The guard was approved 4-0 on a motion by *Alon Glickstein* seconded by *Mike McReynolds*.
