VENTURA/SANTA BARBARA 101 WIDENING LIKELY DELAYED

Because of budgetary issues, the State Treasurer has moved to cancel the Spring 2011 sale of General Obligation Bonds. Given the uncertainty of available transportation funding in the past few years, this comes as no surprise to the Commission.

This cancellation delays projects for VCTC that are currently awaiting additional funding, including the Route 101 Widening from Mussel Shoals to Carpinteria in Santa Barbara County. The delay of the project is disheartening for both counties who have collaborated and spent much of their efforts to see it through.

METROLINK TO CHANGE STATION NAME

VCTC has requested the Montalvo Metrolink Station be officially renamed the East Ventura Station as of Metrolink's next schedule printing. This change is an effort to identify the name of the city in which the station is located. East Ventura Station is more reflective of the area served by the station, thereby making it easier to locate for Metrolink system riders unfamiliar with western Ventura County.

AGRICULTURAL WORKER VANPOOL PROGRAM UPDATE

In July 2009, the Agricultural Worker Vanpool Program began operating in Ventura County. The program was developed to provide safe, efficient, reliable, and affordable vanpool services to agricultural workers commuting to and from worksites in rural areas. In the last 12 months, the Agricultural Worker Vanpool Program has reduced 18,677 auto trips and reduced 3,025,350 Vehicle Miles Traveled.

ON THE STREETS POTHOLES ONLY GETTING WORSE

As recently reported in the Ventura County *Star*, it appears that the inclement weather conditions of last month did nothing to alleviate the problems caused by potholes in Ventura County roadways.

As the state and counties attempt to resolve the problem, it is apparent that without proper maintenance, the streets are rapidly deteriorating. "There is not a quick and easy fix out there at this point," said Darren Kettle, Executive Director of the Ventura County Transportation Commission. Because local government is dependent on the gas tax funding for street repairs, Ventura County is financially impacted. More residents are driving fewer miles and buying cars with better gas mileage. It is estimated that \$380 million is needed for basic road maintenance over the next 10 years, for which there is no projected funding.

The VCTC is in the process of conducting a comprehensive study of transportation issues, including how we maintain our local streets and roads.
