Come together to end homeless crisis in V.C.

In the 1980s, I was working for a retail operation and was also board chairwoman for our local American Red Cross chapter. At the time, the Red Cross owned an old Victorian house on Santa Clara Street in Ventura that was used for meetings and storage space. The Red Cross officers were in an office building next door.

One cold and rainy night, a homeless man was found huddled in a doorway in downtown Ventura. He had died from exposure. In the morning, the executive director of the Ventura Chapter of the Red Cross, called me with the idea that the Red Cross could open up the house on Santa Clara Street and let homeless folks sleep indoors, so that no one else would die on the streets.

Executive Summary

The 2010 County of Ventura Homeless Survey was administered to 431 homeless adults or more than one of every four adults (27%) who were counted in the 2010 County of Ventura Homeless Count. The survey instrument was designed to collect a wide-range of information on homeless individuals as well as to assess their service needs using questions focusing on several areas including: Domestic Violence, Education, Ethnicity, Familial Status, Geo-History, Health Care, Income, Mental Health History, Residency, Substance Abuse History, Veteran's status, etc.

Such information includes:

- ***What is your total current monthly income?***
- ***More than one-third (39%) or 166 stated that they did not have any monthly income;***
- ***More than half (58%) or 250 stated that they had a monthly income of \$300 or less;***
- ***Nearly three-fourths (73%) or 314 stated that they had a monthly income of \$800 or less;***
- ***Nearly 90% (88%) or 378 stated that they had a monthly income of \$1,000 or less.***
- ***What Is The Highest Grade Of School That You Completed?***

Three-fourths (75%) or 324 of all survey respondents completed high school, more than half (56%) or 183 completed some junior college, college, or post-graduate education, 6% or 25 finished college.

- ***Have Any Of The Following Health Problems Impacted Your Daily Functioning for Three (3) Months Or More?***

More than half (55%) or 239 of all survey respondents stated that one or more of the following health problems impacted their daily functioning for three (3) months or more. Among the 239 respondents, 35% or 83 respondents were women and 65% or 156 were men.

- Anemia
- Arthritis
- Asthma
- Cancer
- Deafness
- Dermatitis
- Diabetes

- Digestive Trouble
- Epilepsy
- Heart Trouble
- High Blood Pressure
- Infections
- Obesity
- Respiratory Problems
- Seizures
- Strokes
- Tuberculosis
- Hepatitis

The survey instrument was also designed to compile a cross-section of information concerning several pre-determined sub-populations that included: chronic homeless persons, families with children, men, people living in homeless facilities, people living on the streets, persons with dual diagnoses, persons with HIV/AIDS, persons with mental illness, pregnant women, seniors, substance abusers, various ethnic groups, veterans, victims of domestic violence, unaccompanied youth, and women. As a result, the survey provides a sampling of data that helps examine the issues and needs of each homeless sub-population as well as the entire homeless population.

A close look at some of the sub-populations reveals that

CHRONIC HOMELESS PERSONS

- 57% of the homeless population is chronically homeless;

CHRONICALLY ILL

- 60% of the homeless population is chronically ill;

MENTALLY ILL

- 40% of the homeless population is mentally ill;

SUBSTANCE ABUSERS

- 32% of the homeless population are substance abusers;

VETERANS

- 12% of the homeless population are veterans

VICTIMS OF DOMESTIC VIOLENCE

- 44% of the homeless population are victims of domestic violence

YOUTH (AGES 18 – 24)

- 8% of the homeless population is between 18 and 24 years of age.

The following sections provide greater detail about the homeless survey methodology and information about all of the sub-populations noted above.

I. Introduction

The 2010 County of Ventura Homeless Survey was administered to 431 homeless adults. The number of adults who were surveyed is more than one of every four adults (27%) who were included in the 2010 County of Ventura Homeless Count. Of the 1,815 persons counted, 1,604 were adults.

WHY WAS THE SURVEY CONDUCTED?

The survey was conducted in order to:

1. provide a wide-range of information on a representative sample of adults who were included in the homeless count;
2. obtain HUD required information concerning homeless subpopulations in Continuum of Care Homeless Assistance grant applications;
3. make available information to the County of Ventura to help meet requirements for planning documents such as consolidated plans, housing elements, and impediments to fair housing choice;
4. serve as a basis for developing strategies for public and private agencies to respond to specific needs of homeless families and individuals.

WHEN WAS THE SURVEY CONDUCTED?

The survey was conducted over an eight (8) week period from February through March of 2010.

WHERE WAS THE SURVEY CONDUCTED?

The survey was conducted on the streets and at various residential and non-residential social service sites that participated in the homeless count.

HOW THE SURVEY WAS CONDUCTED?

Representatives from more than 30 public and private agencies, service-providers and faith-based institutions participated in conducting survey interviews throughout the city. The process involved administering a comprehensive one-on-one interview survey with a representative sample of homeless adults living in the County of Ventura. There were three (3) primary methods of contact with homeless persons who participated in the survey. They were: 1) interviews with homeless persons who were contacted on the streets; 2) interviews with homeless persons who were contacted while living in shelters and transitional housing; and 3) interviews with homeless persons who were contacted while using non-residential homeless services.

All surveyors who participated in administering the 100+ survey instrument were trained. Using trained interviewers to administer the survey instead of conducting a self-administered survey instrument increased the opportunity for collecting more complete and accurate responses to the questions and provided opportunity for receiving useful evaluation information from the interviewers.

WHAT WAS INCLUDED IN THE SURVEY?

The survey instrument was designed to collect a wide-range of information on homeless individuals as well as to assess their service needs using questions focusing on several areas including: Domestic Violence, Education, Ethnicity, Familial Status, Geo-History, Health Care, Income, Mental Health History, Residency, Substance Abuse History, Veteran's status, etc.

The survey instrument was also designed to compile a cross-section of information concerning several pre-determined sub-populations that included: chronically homeless persons, families with children, men, people living in homeless facilities, people living on the streets, persons with dual diagnoses, persons with HIV/AIDS, persons with mental illness, pregnant women, seniors, substance abusers, various ethnic groups, veterans, victims of domestic violence, unaccompanied youth, and women. As a result, the survey provides a sampling of data that helps examine the issues and needs of each homeless sub-population as well as the entire homeless population. A copy of the survey instrument is included in Appendix A.

WHO WAS INCLUDED IN THE SURVEY?

Four hundred and thirty one (431) adults participated in the survey providing detailed information about themselves and, when applicable, their children.

A demographic breakdown of survey respondents includes:

Gender

- 138 or 32% were women;
- 293 or 68% were men.

Ethnicity

- 22 or 5% were American Indian or Alaskan Native;
- 6 or 1% were Asian or Pacific Islander;
- 19 or 4% were Black or African American;
- 105 or 25% were Hispanic or Latino;
- 228 or 53% were White;
- 2 or 1% were One or More Ethnicities;
- 49 or 11% were "Other".

Age

- 02 or 0% were unaccompanied youth 17 years of age or younger;
- 34 or 8% were youth between the ages of 18 and 24;
- 36 or 8% were between the ages of 25 and 29;
- 77 or 18% were between the ages of 30 and 39;
- 127 or 29% were between the ages of 40 and 49;
- 77 or 18% were between the ages of 50 and 54;
- 46 or 11% were between the ages of 55 and 59;
- 10 or 2% were between the ages of 60 and 61;
- 15 or 4% were between the ages of 62 and 64;
- 04 or 1% were between the ages of 65 and 69;
- 03 or 1% were 70+ years old.

II. General Profile

A. LOCATION

Questions concerning location (including geo-history) focused on the following areas of concern: places of birth and local “community ties.”

Places of Birth

Survey respondents were asked in what country, state, and city they were born. Responses were as follows:

■ ***In What Country Were You Born?***

88% or 379 of all survey respondents stated that they were born in the United States, 8% or 33 stated Mexico, and 4% or 19 stated some other country which included:

- Africa
- Bolivia
- Canada
- Egypt
- El Salvador
- England
- Germany
- Greece
- Hungry
- Korea
- Panama
- Puerto Rico

■ ***In What State Were You Born?***

More than half (51%) or 222 of all survey respondents stated that they were born in California. Less than half (49%) stated that they were born in some other state in the United States or another country. Among those born in another state,

- 4% or 16 were born in Texas;
- 2% or nine (9) were born in Oregon;
- 3% or five (5) were born in Ohio;
- 2% or seven (7) were born in Illinois;
- 2% or seven (7) were born in Pennsylvania.

Local Community Ties

A range of questions concerning “community ties” to the County of Ventura were asked. Such ties focused on whether survey respondents considered themselves a resident of Ventura County, whether they had family members or friends who lived in the county, or whether they currently worked, worked in the past, or went to school in the county.

Questions that focused on whether survey respondents considered themselves a resident of Ventura County include the following:

■ ***Are You A Resident Of Ventura County?***

Eighty-six percent (86%) or 372 of all survey respondents stated that they were a resident of Ventura County.

■ ***What City Do You Consider Your Home?***

Eighty-six percent (86%) or 372 of all survey respondents stated that they considered one of the cities in Ventura County their home. A breakdown is as follows:

- Ventura - 35% or 149 survey respondents;
- Oxnard - 27% or 117 survey respondents;
- Simi Valley - 10% or 43 survey respondents;
- Thousand Oaks – 6% or 26 survey respondents;
- Santa Paula – 3% or 14 survey respondents;
- Ojai – 3% or 13 survey respondents;
- Camarillo – 2% or eight (8) survey respondents;
- Port Hueneme – 0% or one (1) survey respondent;
- Moorpark – 0% or one (1) survey respondent;
- Fillmore – 0% or no survey respondents.

Another question asked focused on a “local community tie” to a city in Ventura County.

■ ***In What City Did You First Become Homeless?***

Eighty-three percent (83%) or 358 of all survey respondents stated that they first became homeless in a city within Ventura County. A breakdown is as follows:

- Ventura – 33% or 143 survey respondents;
- Oxnard – 26% or 111 survey respondents;
- Simi Valley – 9% or 39 survey respondents;
- Thousand Oaks – 5% or 23 survey respondents;
- Camarillo – 4% or 16 survey respondents;
- Santa Paula – 3% or 14 survey respondents;
- Ojai – 3% or 11 survey respondents;
- Port Hueneme – 0% or one (1) survey respondent;
- Moorpark – 0% or no survey respondents;
- Fillmore – 0% or no survey respondents.

Other questions that focused on “local community ties” to Ventura County included

■ ***Do You Have Family Who Live In Ventura County?***

More than half (54%) or 233 of all survey respondents stated that they have family who live in Ventura County.

- ***Do You Have Friends Who Live In Ventura County?***

Eighty-four percent (84%) or 363 of all survey respondents stated that they have friends who live in Ventura County.

- ***Have You Ever Worked In Ventura County?***

Eighty two percent (82%) or 353 of all survey respondents stated that they worked in Ventura County in the past.

- ***Are You Currently Working In Ventura County?***

Eighteen (18%) or 78 of all survey respondents stated that they were currently working in Ventura County.

- ***Have You Ever Attended School In Ventura County?***

More than half (51%) or 222 of all survey respondents stated that they attended school in Ventura County.

The Question of Residency: Who Is, And Who Is Not, Considered A Resident

The criteria used to consider a “resident” included whether a person first became homeless while living in a city in Ventura County and whether a person had community ties. As previously noted, 83% or 358 survey respondents stated that they first became homeless while living in a city in Ventura County.

A survey respondent was considered to have “community ties” if they answered “yes” to at least three (3) of the following five (5) questions:

- ***Do You Have Family Who Live In Ventura County?***
- ***Do You Have Friends Who Live In Ventura County?***
- ***Have You Ever Worked In Ventura County?***
- ***Are You Currently Working In Ventura County?***
- ***Have You Ever Attended School In Ventura County?***

Of the 358 survey respondents who stated that they first became homeless while living in a city in Ventura County, 256 of them answered “yes” to at least three (3) of the five (5) questions noted above. In addition, there were 19 other survey respondents who answered “yes” to at least three (3) of the five (5) questions noted above but stated that they did not first become homeless while living in a city in Ventura County.

Thus, nearly two-thirds (64%) or 275 of all survey respondents first became homeless while living in a city in Ventura County and/or answered “yes” to at least three (3) of the five (5) questions noted above.

B. LENGTH OF TIME HOMELESS

The primary question in this section focused on the length of time of each survey respondent’s current homeless experience.

■ *How Long Have You Been Currently Homeless?*

Length of Time Homeless	Percent	Number
10 Years Or More	8	33
Five Years Or More	20	88
Three Years Or More	32	139
One Year Or More	59	253

More than half (59%) or 253 of all survey respondents stated that they were currently homeless one year or more. Nearly one-third (32%) or 139 survey respondents stated that they were currently homeless three years or more, 20% or 88 stated five years or more, and 8% or 33 stated 10 years or more.

C. INCOME

Questions concerning income concentrate on employment and public assistance. Employment included part-time and full-time work and public assistance included current and past sources.

Employment

■ *Do You Have a Part-Time Job?*

Twelve percent (12%) or 52 of all survey respondents stated that they had a part-time job. Of the 52 survey respondents, nearly two-thirds (62%) or 32 were men and more than one-third (38%) or 20 were women.

■ *Do You Have a Full-Time Job?*

Seven percent (7%) or 29 of all survey respondents stated that they had a full-time job. Of the 29 survey respondents, nearly two-thirds (65%) or 19 were women and more than one-third (35%) or 10 were men.

Nineteen percent (19%) or 81 of all survey respondents stated that they had a part-time or full time job.

Public Assistance

■ ***Do You Receive Any Of The Following Kinds Of Monthly Incomes?***

More than three-fourths (76%) or 175 of all survey respondents stated that they were receiving one or more types of public assistance noted below. More survey respondents were receiving Food Stamps (39%), General Relief (37%), Medi-Cal/Medicare (23%), and Social Security-Disability (17%) than other types of public assistance.

Total Monthly Income

■ ***What is your total current monthly income?***

Of the 227 survey respondents who answered this question:

- More than one-third (39%) or 166 stated that they did not have any monthly income;
- More than half (58%) or 250 stated that they had a monthly income of \$300 or less;
- Nearly three-fourths (73%) or 314 stated that they had a monthly income of \$800 or less;
- Nearly 90% (88%) or 378 stated that they had a monthly income of \$1,000 or less.

D. MARITAL STATUS

There was only one question concerning marital status which was:

- ***What Is Your Marital Status?***

Eight percent (8%) or 35 of all survey respondents stated that they were currently married. Of those who were not, 54% or 233 stated that they were single, 26% or 111 stated that they were divorced, and all others (12%) or 52 survey respondents stated that they were separated, widowed, or stated Other.

E. VETERAN STATUS

The primary question concerning veteran status was:

- ***Are You A Veteran?***

Twelve percent (12%) or 51 of all survey respondents stated that they were a veteran. However, the number of men who were veterans is higher than women—48 or 16% of the total number of men (292) who were survey respondents stated that they were a veteran, compared to 3 or 2% of the total number of women (137) who were survey respondents.

Other questions concerning veteran status included:

- ***What Is Your Period of Service?***

Of the 51 veterans

- two (2) or 4% served pre-Vietnam War;
- 14 or more than one-fourth 27% served during the Vietnam War;
- 35 or more than two-thirds (68%) served post-Vietnam War;
- eight (8) or 16% served during the Persian Gulf War; and
- one (1) served during the Iraqi War.

- ***Do You Have A Veteran's Administration Medical Card?***

Of the 51 veterans who answered this question, 20 or 39% of all veterans stated that they have a Veteran's Administration Medical Card.

- ***Have You Used Any Veteran Services In The Past?***

Of the 51 veterans who answered this question, 25 or nearly half (49%) of all veterans stated that they have used veteran services in the past.

F. DOMESTIC VIOLENCE AND ASSAULT

There were three (3) questions that were asked that concerned domestic violence and one question concerning physical assault. The two (2) questions concerning domestic violence were as follows:

- ***Have You Ever Been Abused/Mistreated By A Spouse Or Intimate Partner?***

More than one-fourth (29%) or 126 of all survey respondents stated that they had been abused/mistreated by a spouse or intimate partner. Among the 126 respondents, nearly two-thirds (62%) or 81 respondents were women and more than one-third (36%) or 45 were men.

The percentage of women who were abused/mistreated was higher than men—more than half (59%) or 81 of the total number of women who were survey respondents (137) stated that they were abused/mistreated, compared to 15% or 45 of the total number of men (292) who were survey respondents.

- ***Have You Ever Been Abused/Mistreated By A Parent Or Relative?***

Nearly one-third one-fourth (31%) or 135 of all survey respondents stated that they had been abused/mistreated by a parent or relative. Among the 135 respondents, 40% or 54 respondents were women and 60% or 81 were men.

The percentage of women who were abused/mistreated was higher than men—more than a third (39%) or 54 of the total number of women (137) who were survey respondents, stated that they were abused/mistreated, compared to more than one-fourth (28%) or 81 of the total number of men (292) who were survey respondents.

- ***Have You Ever Been Abused/Mistreated By Someone Other Than A Spouse, Intimate Partner, Parent, Or Relative?***

Nearly one-fourth (22%) or 97 of all survey respondents stated that they had been abused/mistreated by someone other than a spouse, intimate partner, or relative. Among the 97 respondents, 40% or 39 respondents were women and 60% or 58 respondents were men.

The percentage of men who were abused/mistreated was higher than women—more than one fourth (28%) or 39 of the total number of women (137) who were survey respondents stated that they were abused/mistreated, compared to 20% or 58 of the total number of men (292) who were survey respondents.

- ***Have You Ever Been A Victim Of Assault While Living On The Street?***

More than one-third (35%) or 149 of all survey respondents stated that they had been a victim of assault while living on the street. Of the 149 respondents, nearly three-fourths (73%) or 109 respondents were men and more than one-fourth (27%) or 40 were women.

The percentage of men who were assaulted was higher than women—more than one-third (37%) or 109 of the total number of men (292) who were survey respondents stated that they were assaulted, compared to more than one-fourth (29%) or 40 of the 137 women who were survey respondents.

- ***Was The Assault Physical or Sexual?***

Of the 40 women who were physically assaulted, nearly half (45%) or 18 were physically and sexually assaulted. Of the 109 men who were physically assaulted, 9% or 10 were physically and sexually assaulted.

G. HEALTH STATUS

There were several questions concerning health care that focused on disability, health problems, and dental and vision care. They included the following:

- ***Do You Have A Physical Or Developmental Disability That Impairs Any Activities Such As Walking, Eating, Breathing, Reading, Etc.?***

Thirty three percent (33%) or 144 of all survey respondents stated that they have a physical or developmental disability that impairs activities such as walking, eating, breathing, reading, etc. Among the 144 respondents, 71% or 103 respondents were men and 29% or 41 were women.

The percentage of men who had a disability was higher than women—35% or 103 of the total number of men (292) who were survey respondents stated that they had a disability compared to 30% or 41 of the total number of women (137) who were survey respondents.

- ***Do You Use Any Equipment Because Of Your Disability?***

Of the 144 survey respondents who stated that they have a physical or developmental disability that impairs activities such as walking, eating, breathing, reading, etc., 12% or 54 respondents stated that they use equipment because of their disability.

■ ***Have Any Of The Following Health Problems Impacted Your Daily Functioning for Three (3) Months Or More?***

More than half (55%) or 239 of all survey respondents stated that one or more of the following health problems impacted their daily functioning for three (3) months or more. Among the 239 respondents, 35% or 83 respondents were women and 65% or 156 were men.

The percentage of women was higher than men—60% or 83 of the total number of women (137) who were survey respondents had one or more of the following health problems and 53% or 156 of the total number of men (292) who were survey respondents.

■ ***Have Any Of The Following Health Problems Impacted Your Daily Functioning For Three (3) Months Or More?***

■ ***Have You Been Able To Obtain Services For The Health Care Needs You Noted Above When Needed?***

More than one-third (36%) or 157 of all survey respondents stated that they have been able to obtain services for their health care needs. Among the 157 respondents, 67% or 105 respondents were men and 33% or 52 were women.

- More than one-third (38%) or 52 of the total number of survey respondents (137) who were women were able to obtain services for their health care needs;
- More than one-third (36%) or 105 of the total number of survey respondents (292) who were men were able to obtain services for their health care needs.

■ ***Do You Currently Need Health Care Services For Any Of The Conditions You Listed Above?***

More than one-third (36%) or 154 of all survey respondents stated that they currently needed health care services for their health care problems. Among the 81 respondents, 35% or 54 respondents were women and 65% or 100 were men.

- More than one-third (39%) or 54 of the total number of survey respondents (137) who were women, needed health care services for their health care problems;
- More than one-third (34%) or 100 of the total number of survey respondents (292) who were men needed health care services for their health care problems.

■ ***Have You Had A Dental Exam During The Past Year?***

More than one-fourth (29%) or 126 of all survey respondents stated that they had a dental exam during the past year. Among the 126 respondents, 36% or 46 respondents were women and 64% or 80 were men.

- More than one-third (34%) or 46 of the total number of survey respondents (137) who were women had a dental exam during the past year;
- More than one-fourth (27%) or 80 of the total number of survey respondents (292) who were men had a dental exam during the past year.

■ ***Have You Been Able To Obtain Dental Care When You Needed It?***

More than one-third (37%) or 160 of all survey respondents were able to obtain dental care when needed. Among the 160 respondents, 29% or 46 respondents were women and 71% or 114 were men.

- More than one-third (34%) or 46 of the total number of survey respondents (137) who were women were able to obtain dental care when needed;
- More than one-third (39%) or 114 of the total number of survey respondents (292) who were men were able to obtain dental care when needed.

■ ***Do You Need Dental Care At This Time?***

Nearly three-fourths (70%) or 304 of all survey respondents stated that they needed dental care. Among the 165 respondents, 36% or 111 were women and 64% or 192 were men.

- More than three-fourths (81%) or 111 of the total number of survey respondents (137) who were women stated that they needed dental care;
- Two-thirds (66%) or 192 of the total number of survey respondents (292) who were men stated that they needed dental care.

■ ***Have You Had A Vision Exam During The Past Year?***

Nearly one-third (30%) or 129 of all survey respondents stated that they had a vision exam during the past year. Among the 129 respondents, 34% or 44 respondents were women and 66% or 85 were men.

- Nearly one-third (32%) or 44 of the total number of survey respondents (137) who were women had a vision exam during the past year;
- More than one-fourth (29%) or 85 of the total number of survey respondents (292) who were men had a vision exam during the past year.

■ ***Have You Been Able To Obtain Vision Care When You Needed It?***

Nearly half (43%) or 187 of all survey respondents stated that they were able to obtain vision care when needed and nearly half (46%) were not. Among the 187 respondents, 33% or 62 respondents were women and 67% or 125 were men.

- Nearly half (45%) or 62 of the total number of survey respondents (137) who were women were able to obtain vision care when needed;
- Nearly half (42%) or 125 of the total number of survey respondents (292) who were men were able to obtain vision care when needed.

■ ***Do You Need Vision Care At This Time?***

More than half (56%) or 241 of all survey respondents stated that they needed vision care. Among the 241 respondents, 37% or 89 were women and 63% or 150 were men.

- Nearly two-thirds (65%) or 89 of all survey respondents who were women (137) stated that they needed vision care at the time of the survey;
- More than half (51%) or 150 of all survey respondents who were men (292) stated that they needed vision care at the time of the survey.

- ***Have You Had A Prescription You Could Not Fill?***

More than one-third (35%) or 150 of all survey respondents stated that they had a prescription that they could not fill. Forty percent (40%) or 60 respondents were women and 60% or 90 were men.

H. FOSTER CARE

Questions concerning foster care centered on current and past placement and incidents of homelessness during and after placement. They included:

- ***Are You Currently In The Foster Care System?***

0 or 0% of all survey respondents were currently in the foster care system.

- ***Have You Ever Been In The Foster Care System?***

Five percent (5%) or 22 of all survey respondents stated that they had been in the foster care system.

- ***When Were You Released From The Foster Care System?***

Of the 22 survey respondents that stated they had been in the foster care system, 95% or 21 had been released from the foster care system one year or more ago.

- ***Were You Homeless During The Time You Were In Foster Care?***

Of the 22 survey respondents that stated they had been in the foster care system, 18% or 4 stated that they were homeless during the time they were in foster care.

I. HIV/AIDS

Questions about HIV/AIDS focused on testing for HIV/AIDS and having HIV/AIDS. They included:

- ***Have You Ever Been Tested For HIV/AIDS?***

Three-fourths (75%) or 325 survey respondents stated that they had been tested for HIV/AIDS.

- ***Do You Know Your Results?***

Of the 325 survey respondents that stated that they had been tested for HIV/AIDS, 93% or 304 stated that they knew their results.

- ***Are You HIV+?***

One percent (1%) or six (6) survey respondents stated that they were HIV+.

J. PREGNANCY

There was just one (1) primary question concerning pregnancy which was,

- ***Are You Pregnant?***

There was one (1) survey respondent who stated that she was pregnant.

K. DRUG HISTORY

There were several questions concerning different types of drug use. Each question asked if the survey respondent was currently using, used in the past, or never used a drug or substance. The last question asked if the survey respondent had a substance abuse problem. The primary question was:

- ***Do You Now Use, Or Have You Ever Used, Any Of The Following Drugs?***

- ***Do You Have A Substance Abuse Problem?***

Nineteen percent (19%) or 84 of all survey respondents stated that they have a substance abuse problem.

L. TOBACCO

The questions about tobacco focused on frequency of use and interest in quitting. They include:

- ***Do You Smoke?***

Nearly two-thirds (60%) or 259 of all survey respondents stated that they smoke cigarettes.

- ***How many Cigarettes Do You Smoke Per Day—less than one pack; one pack; or two or more packs?***

When asked how “many cigarettes do you smoke per day” nearly three-fourths (70%) or 182 of the 259 survey respondents stated “less than one pack,” 25% or 65 stated “one pack,” and 5% or 12 stated “two or more packs.”

- ***How Interested Are You In Quitting Smoking—not interested; somewhat interested; or very interested?***

When asked if they were interested in quitting, one-third (33%) or 87 of the 259 survey respondents stated “not interested,” more than one-fourth (24%) or 61 stated “somewhat interested,” and nearly half (43%) or 111 stated “very interested.”

- ***Do You Chew Tobacco?***

Four percent (4%) or 19 of all survey respondents stated that they chew tobacco.

- ***How Interested Are You In Quitting—not interested; somewhat interested; or very interested?***

Of the 19 survey respondents, more than two-thirds (68%) or 13 were “not interested” in quitting, 10% or 2 stated “somewhat interested,” and 21% or 4 stated “very interested.”

M. EDUCATION

Questions about education asked about the highest grade completed, vocational training, and business school attendance. They specifically asked

- ***What Is The Highest Grade Of School That You Completed?***

Three-fourths (75%) or 324 of all survey respondents completed high school, more than half (56%) or 183 completed some junior college, college, or post-graduate education, 6% or 25 finished college.

- ***Have You Ever Completed A Vocational Training Course?***

More than one-third (38%) or 162 of all survey respondents stated that they completed a vocational training course.

- ***Have You Ever Attended A Business School?***

Twelve percent (12%) or 52 of all survey respondents stated that they attended a business school.

N. MENTAL HEALTH

There were several questions about mental health symptoms and medications, which are given below. In addition, there was a question that was answered by the interviewer which was, —Does the interviewee act/converse in a mentally unstable manner.

- ***Have You Ever Been Diagnosed With A Mental Or Emotional Problem?***
More than one-third (35%) or 153 of all survey respondents stated that they have been diagnosed with a mental or emotional problem.
- ***If Yes, Have You Experienced Any Symptoms Of This Diagnosis Within The Past Year?***
Of the 153 survey respondents who stated that they have been diagnosed with a mental or emotional problem, more than three-fourths (76%) or 116 stated had experienced symptoms within the past year.
- ***Have You Ever Been Prescribed Medications For Mental Or Emotional Problems?***
Nearly half (41%) or 178 of all survey respondents stated that they had been prescribed medications for mental or emotional problems.
- ***If Yes, Are You Currently Taking Any Psychotropic (Psychiatric) Medications?***
Of the 178 survey respondents who stated that they had been prescribed medications for mental or emotional problems, nearly half (41%) or 73 stated that they were currently taking psychotropic medications.
- ***Have You Been Hospitalized For Psychiatric Problems During The Past Year?***
Thirteen percent (12%) or 50 of all survey respondents stated that they had been hospitalized for psychiatric problems during the past year.
- ***If No, Have You Ever Been Hospitalized For Psychiatric Reasons?***
Of those survey respondents who stated “no” when asked if they had been hospitalized for psychiatric reasons during the past year, 19% or 81 stated “yes” when asked if they had ever been hospitalized for psychiatric reasons.
- ***Have You Ever Seen A Counselor For Help While Dealing With Your Emotions Or Stress?***
More than half (53%) or 121 of all survey respondents stated that they had seen a counselor for help while dealing with emotions or stress.

- ***Have Friends Or Family Ever Expressed Concern About Your Mental Health?***
 Nearly half (48%) or 208 of all survey respondents stated that friends or family expressed concern about their mental health.
- ***Does The Interviewee Act/Converse In A Mentally Unstable Manner (answered by the Interviewer)?***
 Seven percent (7%) or 31 of all survey respondents acted/conversed in a mentally unstable manner according to the interviewers.

O. RELIGION

Questions concerning religion focused on personal faith, service attendance, and its impact on people during their homeless experience. They included:

- ***Do You Consider Yourself A Religious Person?***
 Nearly three-fourths (72%) or 309 of all survey respondents stated that they considered themselves a religious person.
- ***Are You A Member Of A Religious Faith?***
 Nearly two-thirds (63%) or 273 of all survey respondents stated that they were members of a religious faith.
- ***Do You Regularly Attend A Religious Service?***
 Nearly half (47%) or 202 of all survey respondents stated that they attend a religious service.
- ***Were You Raised As A Child In A Religious Home?***
 Nearly two-thirds (66%) or 286 of all survey respondents stated that they were raised as a child in a religious home.
- ***Has Your Faith Increased Or Decreased During Your Homeless Experience?***
 Nearly three-fourths (72%) or 309 of all survey respondents stated that their faith increased during their homeless experience.

P. CHILDREN

There were 42 children living with survey respondents. Questions concerning children were answered by the adult survey respondents who were with them. Questions included:

- ***Do You Have Any Children Living With You?***

Ten percent (10%) or 42 of all survey respondents stated that they had children living with them.

- ***How Many?***

Of the 42 survey respondents, nearly half (43%) or 18 survey respondents stated one (1) child, nearly half (45%) or 19 stated two (2) children; and 12% or 5 stated three (3) children or more.

- ***Is Your Child Enrolled In School?***

Nearly three-fourths (74%) or 31 of the 42 children were enrolled in school.

- ***Have You Been Able To Obtain Health Care For Your Children?***

Eighty eight (88%) or 37 of 42 survey respondents stated that they were able to obtain health care for their children.

- ***Have You Been Able To Provide Three Meals A Day For Your Children?***

Ninety percent (90%) or 38 of 42 survey respondents stated that they were able to provide three (3) meals a day for their children.

- ***Are You The Only Parent In Your Household?***

Nearly three-fourths (74%) or 31 of 42 survey respondents stated that they were the only parent in their household.

III. SUB-POPULATIONS

The survey instrument was designed to compile a cross-section of information concerning several pre-determined sub-populations that included:

- A. Chronic Homeless Persons;
- B. Men;
- C. Persons with Chronically Illness;
- D. Persons with Mental Illness;
- E. Substance Abusers;
- F. Veterans;
- G. Victims of Domestic Violence;
- H. Women; and
- I. Youth Ages 18 – 24.

As a result, the survey provides a sample of data that helps examine several of the issues and needs of each homeless sub-population.

There were three (3) sub-populations that were pre-determined but not included in this section. They were persons with HIV/AIDS, veterans, and unaccompanied youth under age 18. They were not included because very survey respondents who stated that they had HIV/AIDS, or were veterans, or were an unaccompanied youth under age 18 was small. Eight (8) survey respondents stated that they had HIV/AIDS, eight (8) stated that they were a veteran, and one (1) was an unaccompanied youth under age 18.

A. CHRONIC HOMELESS PERSONS

Key Finding: *57% of all survey respondents were chronically homeless.*

Of the 431 survey respondents, 244 or 57% were chronically homeless.

According to HUD, a chronic homeless person is an unaccompanied homeless individual with a disabling condition who has either been continuously homeless for a year or more or has had at least four (4) episodes of homelessness in the past three (3) years. Disabling condition is defined as “a diagnosable substance (abuse), serious mental illness, developmental disability, or chronic physical illness or disability, including the co-occurrence of two or more of these conditions.” Also, to be considered chronically homeless, persons must have been sleeping in a place not meant for human habitation (e.g., living on the streets) or in an emergency homeless shelter during that time.

The following information provides a profile of chronic homeless persons based upon the responses of 244 or 57% of survey respondents. Information includes gender, ethnicity, age, location, chronic homelessness, residency, employment, public assistance, income, marital status, veteran status, domestic violence, chronic illness, foster care, HIV/AIDS, pregnancy, substance abuse, tobacco, education, mental illness, religion, and children.

Gender:

- 68% were men and 32% were women.

Ethnicity:

- 7% were American Indian or Alaskan Native; 0% were Asian; 5% were African American/Black; 16% were Hispanic/Latino; 58% were White; and 14% were one or more race or stated Other.

Age:

- 6% were youth between the ages of 18 and 24; 18% were under the age of 40; 69% were age 40 – 61; and 7% were 62 years of age or older.

Location:

Country Born

- 92% were born in the United States; 4% were born in Mexico; and 4% in other countries.

State Born

- 53% were born in the State of California and 47% were born in other states.

Chronic Homelessness:

- 100% were chronically homeless.

Residency¹:

- 63% were residents of Ventura County.

Employment:

- 16% were employed—11% were employed part-time and 5% full-time.

Total Income:

- 9% had no income.

Marital Status:

- 8% were currently married and 92% were single.

Veteran Status:

- 15% were veterans.

Victim of Domestic Violence:

- 49% had experienced domestic violence.

Chronically Ill:

- 80% were chronically ill.

Foster Care:

- 0% were currently in foster care and 7% had been in the foster care system in the past.

HIV/AIDS:

- 2% were HIV+.

¹The criteria used to identify a “resident” were based on whether they first became homeless while living in Ventura County and whether they had “community ties” which was based on whether they answered “yes” to at least three (3) of the following five (5) questions: 1) Do You Have Family Who Live In Ventura County?; 2) Do You Have Friends Who Live In Ventura County?; 3) Have You Ever Worked In Ventura County?; 4) Are You Currently Working In Ventura County?; and 5) Have You Ever Attended School In Ventura County?

Pregnancy:

- 0% of chronically homeless women were pregnant.

Substance Abuse:

- 42% were currently abusing alcohol and/or other drugs.

Tobacco:

- 64% were currently smoking;

Among those who were currently smoking:

- 37% were not interested in quitting;
- 24% were somewhat interested in quitting;
- 39% were very interested in quitting.

Education:

- 75% completed high school and 12% were a college graduate.

Mental Illness:

- 51% had mental illness.

Religion:

- 68% considered themselves a religious person;
- 61% were a member of a religious faith;
- 42% regularly attended a religious service;
- 70% were raised in a religious home;
- 71% stated that their faith increased during their homeless experience.

Children:

- 66% had children;
- 8% had children currently living with them.

B. MEN

Key Finding: *68% of all survey respondents were men.*

Of the 431 survey respondents, 292 or 68% were men.

The following information provides a profile of men based upon the responses of 292 or 68% of survey respondents. Information includes gender, ethnicity, age, location, chronic homelessness, residency, employment, public assistance, income, marital status, veteran status, domestic violence, chronic illness, foster care, HIV/AIDS, pregnancy, substance abuse, tobacco, education, mental illness, religion, and children.

Gender:

- 100% were men.

Ethnicity:

- 5% were American Indian or Alaskan Native; 2% were Asian; 4% were African American/Black; 23% were Hispanic/Latino; 56% were White; and 10% were one or more race or stated Other.

Age:

- 8% were youth between the ages of 18 and 24; 22% were under the age of 40; 64% were age 40 – 61; and 6% were 62 years of age or older.

Location:

Country Born

- 86% were born in the United States; 10% were born in Mexico; and 4% in other countries.

State Born

- 48% were born in the State of California and 52% were born in other states.

Chronic Homelessness:

- 56% were chronically homeless.

Residency²:

- 60% were residents of Ventura County.

Employment:

- 14% were employed—11% were employed part-time and 3% full-time.

Total Income:

- 7% had no income.

Marital Status:

- 7% were currently married and 93% were single.

Veteran Status:

- 6% were veterans.

Victim of Domestic Violence:

- 33% had experienced domestic violence.

Chronically Ill:

- 60% were chronically ill.

Foster Care:

- 0% were currently in foster care and 5% had been in the foster care system in the past.

HIV/AIDS:

- 1% were HIV+.

Pregnancy:

- n/a.

² The criteria used to identify a “resident” were based on whether they first became homeless while living in Ventura County and whether they had “community ties” which was based on whether they answered “yes” to at least three (3) of the following five (5) questions: 1) Do You Have Family Who Live In Ventura County?; 2) Do You Have Friends Who Live In Ventura County?; 3) Have You Ever Worked In Ventura County?; 4) Are You Currently Working In Ventura County?; and 5) Have You Ever Attended School In Ventura County?

Substance Abuse:

- 36% were currently abusing alcohol and/or other drugs.

Tobacco:

- 62% were currently smoking;

Among those who were currently smoking:

- 36% were not interested in quitting;
- 24% were somewhat interested in quitting;
- 41% were very interested in quitting.

Education:

- 67% completed high school and 9% were a college graduate.

Mental Illness:

- 37% had mental illness.

Religion:

- 69% considered themselves a religious person;
- 61% were a member of a religious faith;
- 45% regularly attended a religious service;
- 66% were raised in a religious home;
- 70% stated that their faith increased during their homeless experience.

Children:

- 58% had children;
- 2% had children currently living with them.

C. PERSONS WITH CHRONIC ILLNESS

Key Finding: 60% of all survey respondents were chronically ill.

Of the 431 survey respondents, 260 or 60% were chronically ill.

Persons were considered chronically ill if they answered “yes” to question 35 which was “Do you have a physical or developmental disability that impairs any activities such as walking, eating, breathing, reading, etc.” and if they answered “yes” to question 37 which was “Have any of the following health problems impacted your daily functioning for three (3) months or more” and noted one or more of the listed health problems.

The following information provides a profile of persons who were chronically ill based upon the responses of 260 or 60% of survey respondents. Information includes gender, ethnicity, age, location, chronic homelessness, residency, employment, public assistance, income, marital status, veteran status, domestic violence, chronic illness, foster care, HIV/AIDS, pregnancy, substance abuse, tobacco, education, mental illness, religion, and children.

Gender:

- 67% were men and 33% were women.

Ethnicity:

- 6% were American Indian or Alaskan Native; 2% were Asian; 4% were African American/Black; 19% were Hispanic/Latino; 54% were White; and 15% were one or more race or stated Other.

Age:

- 4% were youth between the ages of 18 and 24; 20% were under the age of 40; 68% were age 40 – 61; and 8% were 62 years of age or older.

Location:

Country Born

- 89% were born in the United States; 5% were born in Mexico; and 6% in other countries.

State Born

- 49% were born in the State of California and 51% were born in other states.

Chronic Homelessness:

- 75% were chronically homeless.

Residency³:

- 44% were residents of Ventura County.

Employment:

- 13% were employed—among those employed, 10% were employed part-time and 3% full-time.

Total Income:

- 8% had no income.

Marital Status:

- 10% were currently married and 90% were single.

Veteran Status:

- 15% were veterans.

Victim of Domestic Violence:

- 52% had experienced domestic violence.

Chronically Ill:

- 100% were chronically ill.

Foster Care:

- 0% were currently in foster care and 6% had been in the foster care system in the past.

HIV/AIDS:

- 2% were HIV+.

- 0% of chronically ill women were pregnant.

Substance Abuse:

- 35% were currently abusing alcohol and/or other drugs.

Tobacco:

- 63% were currently smoking;

Among those who were currently smoking:

- 38% were not interested in quitting;
- 23% were somewhat interested in quitting;
- 39% were very interested in quitting.

Education:

- 67% completed high school and 9% were a college graduate.

Mental Illness:

- 48% had mental illness.

Religion:

- 71% considered themselves a religious person;
- 65% were a member of a religious faith;
- 46% regularly attended a religious service;
- 71% were raised in a religious home;
- 73% stated that their faith increased during their homeless experience.

Children:

- 70% had children;
- 6% had children currently living with them.

D. PERSONS WITH MENTAL ILLNESS

Key Finding: 40% of all survey respondents were persons with mental illness.

Of the 431 survey respondents, 172 or 40% were persons with mental illness.

Persons were considered mentally ill if they answered yes to both questions within any of the following sets:

- *Have you ever been diagnosed with a mental or emotional problem?*
- *If YES, have you experienced any symptoms of this diagnosis within the past year?*

- *Have you ever been diagnosed with a mental or emotional problem?*
- *Does the interviewee act/converse in a mentally unstable manner?*

- *Have you ever been prescribed medications for mental or emotional problems?*
- *If YES, Are you currently taking any psychotropic (psychiatric) medications?*

- *Have you ever been prescribed medications for mental or emotional problems?*
- *Does the interviewee act/converse in a mentally unstable manner?*

- *Have you been hospitalized for psychiatric problems during the past year?*
- *Does the interviewee act/converse in a mentally unstable manner?*

- *If NO, have you ever been hospitalized for psychiatric reasons?*
- *Does the interviewee act/converse in a mentally unstable manner?*

- *Have you ever seen a counselor for help dealing with your emotions or stress?*
- *Does the interviewee act/converse in a mentally unstable manner?*

- *Have friends or family ever expressed concern about your mental health?*
- *Does the interviewee act/converse in a mentally unstable manner?*

Persons were also considered mentally ill if the answer was “yes” to any three (3) of the questions noted above.

The following information provides a profile of persons with mental illness based upon the responses of 172 or 40% of survey respondents. Information includes gender, ethnicity, age, location, chronic homelessness, residency, employment, public assistance, income, marital status, veteran status, domestic violence, chronic illness, foster care, HIV/AIDS, pregnancy, substance abuse, tobacco, education, mental illness, religion, and children.

Persons were considered substance abusers if they answered yes to the following question: “Do you have a substance abuse problem” and if they stated that they currently use alcohol and marijuana and/or if they stated that they currently use one or more of the following drugs:

- Uppers, speed (including methamphetamines)
- Downers
- Tranquilizers
- Cocaine or Crack
- PCP, LSD
- Heroin

Conclusion

The results of the 2010 County of Ventura Homeless Count combined with the results of the 2010 County of Ventura Homeless Survey provides information that serves as the basis for three (3) important tasks:

- understanding the nature and extent of the current trends in homelessness in Ventura County communities;
- responding to the unmet needs and gaps in services for homeless individuals and families in Ventura County;
- developing local community and countywide strategies to meet the goal of ending homelessness over the next ten years.

The challenge is to develop solution-oriented approaches through a well-coordinated, outcome driven social service system designed to directly meet the needs of our local homeless population. Such activities will further build upon collaborative efforts between homeless service providers, business enterprises, residents, faith-based organizations, other community agencies, and local government that will provide service-enriched program environments in which homeless persons will receive the tools necessary to achieve self-sufficiency and maintain permanent housing.

Thus, an important use of this report is to provide accurate information necessary to design and implement the housing and social service assistance needed to bring homeless persons back into our workforce, schools, faith-based institutions, and other community institutions and provide the means for them to become stable, productive contributors to our communities.
