STATEMENT

I, _____, request that I be considered as a candidate for the Ventura County Grand Jury for Fiscal Year 2018-2019. I understand that, if selected as a prospective Grand Juror, I will be required to attend a two day orientation program in June 2018.

I am aware that such service requires that I attend Grand Jury meetings and activities approximately 30 hours per week, consisting of a minimum of three days per week and often as many as five days per week. In this regard, I understand that as a Grand Juror I must be flexible and able to serve some evening and weekend hours as well as work during normal business hours. I understand that it is essential that all Grand Jury members attend general meetings and meetings of assigned committees and make every effort to attend briefings by and visits to various county governmental units. Reasonable accommodations are made for illness and vacations with appropriate notice to the Foreperson.

I declare that I will be available to serve during those day and evening hours required. I understand that I need to have computer, internet, and word processing capabilities.

I understand that each member of the Grand Jury receives payment of twenty-five dollars (\$25.00), taxable, for each day's attendance from July 1, 2018 through June 30, 2019. Mileage expense will be compensated for each mile traveled on Grand Jury business.

I have read and understood the above and state that I do not have and will not take on obligations which would prevent me from meeting the requirements for service on the Ventura County Grand Jury.
