\*Livable Communities Committee is the new "working title" of the Housing & Transportation Committee. The committee will continue to function as the Housing & Transportation Committee (pursuant to Advisory Council by-laws). Using the phrase, *Livable Communities,* in the name is more reflective of the committee's purpose, and is consistent with contemporary jargon.

The **Livable Communities Committee** focuses on affordable housing and transportation issues that face Ventura County involving persons aged 60 and older, and persons with disabilities. The goal is to help older adults, and persons with disabilities, to remain living as independently as possible in Ventura County; and to advocate for policies and programs that will provide this population with access to transportation as well as a safe and affordable home environment. Activities include:

#### TRANSPORTATION:

• Identify transportation issues and resources in each community;

• Identify, establish and maintain a relationship with transportation providers and stakeholders relative to addressing transportation issues.

• Help seniors who do not drive by identifying, advocating for, and educating them about, alternate transportation (including education about route systems and time schedules of local transit);

## HOUSING:

Identify housing issues and resources in each community;

• Identify the need for affordable housing for older adults, and advocate for such housing.

• Advocate for the incorporation of Aging in Place concepts, including Universal Design, in affordable housing.

• Identify, establish and maintain a relationship with community-based organizations, city and County planners, and other stakeholders to address housing issues.
