Lisa Hayden is the guest. b. There are two classes in Spanish on Family-to-Family: April 10 at the Wellness Center, Oxnard and April 12 at Santa Paula. Classes in English scheduled June in Camarillo are full. c. NAMI Walk is on May 3, Ventura Promenade. Flyers and brochures provided as handouts. VIII A. Mental Health Update – Pam Fisher, Adult Division Manager 1. The Department of Health Care Services (DHCS) conducted an audit last month. The audit consisted of two parts: System Review and Chart Review. Overall, the audit was successfully completed with minor shortfalls. It was noted that there was a 100% approval on test calls to STAR/Crisis Team and that 20 charts were reviewed. The department is awaiting final report from the DHCS. 2. The department is developing a Request for Proposal (RFP) for the locked MHRC project (new name is Horizon View) which is expected to open in 2016. The timeline is dependent on the selection of Contractor, Board of Supervisor (BOS) approval, and construction completion. 3. Expected finish date of Centerpoint Mall Clinic is mid-September. This clinic will serve approximately one half of Oxnard's enrolled children and 2/3 of Oxnard's enrolled adults. 4. The Housing and Jail Report for the month of February is available as a handout. B. Older Adults Program – Meredyth Leafman a. Older Adults has expanded the groups available to the clients. In the East County, there will be a Women's Tea and Spring Fling in Simi Valley and Hoedown in Ralston. b. Rehab groups have 14 consistent clients in attendance at the two residential facilities for the elderly who serve mentally ill seniors. A men's group has recently been added. Road Runner provides transportation for this population. c. Ms. Leafman and Victoria Bradley, CA, are presenting at the Senior Resource Fair on April 16 in Camarillo. d. There are 77 consumers out of 90 have been enrolled in Health Navigation. C. EPICS & ARS/CONTINUUM OF CARE – Mary Stahlhuth Ms. Stahlhuth recently assumed post to manage EPICS/ARS making sure that consumers are connected. She is also the contract liaison for the ANKA and CRT programs. Monthly training with Board & Care operators are conducted every 2nd Friday of the month. Next training is scheduled on May 9. It was suggested that TAY and Homeless populations be topics at future trainings. IX. **ADP Update** Dr. Linda Gertson (on behalf of Patrick Zarate) 1. The Alcohol and Drug Program population continues to expand data from Ventura High School. On sight services are available at the school. This program aims to provide assistance to students on alcohol

	 and drug issues. Recently concluded graduation for New Start for Moms. This is a unique program in VCBH treating mothers with alcohol and drug issues and at risk of losing minor children. This is an MH/ADAB integrated program focusing on trauma issues which provides a safe treatment environment. Dr. Gertson announced that the department is participating in a criminal justice forum at Cal Lutheran with emphasis on local trends about substance abuse with particular emphasis to adolescents' use of marijuana.
