VII.	 Presentation – Telecare VIPS, Azucena de Acevedo Ms. De Acevedo gave a brief background about the Ventura early Intervention and Prevention Service (VIPS). Ms. De Acevedo discussed the different myths and facts of mental illness and how to make a referral. She presented the multi-disciplinary team of VIPS composed of Barry Boatman, Program Director, E. Rodriguez, RN, Susan de Acevedo, Bilingual/Bicultural Therapist, Joshua Tirado, Education/Employment Specialist, and Dr. Fredrick, Psychiatrist.

Ms. De Acevedo mentioned that their treatment program is designed to educate the community about severe mental illness and early signs of psychosis, provide treatment to young people and their families to slow the progression of several mental illness, and reduce the stigma around severe mental illness. 5.
