## Activities and accomplishments for 2015-2016

During the past year, the Committee:

- Received regular updates on the changes that Ventura County Behavioral Health (VCBH) made to the handling of crisis calls related to children and youth. VCBH contracted with Casa Pacifica to respond by phone and in person to children and youth in crisis. For the Fiscal Year 2016-17, VCBH did not renew the contract. As of 7/1/16 VCBH will begin providing crisis response to youth and families as part of the Crisis Team. This shift was implemented over several months in collaboration with Casa Pacifica.
   Committee members were concerned that this change may result in a decline in the quality of the response.
- Received updates on the opening of a children's Crisis Stabilization Unit (CSU) in Oxnard. It
  will provide services to children age 6-18 who are in crisis but for whom hospitalization is not
  appropriate. VCBH is also planning to open in the same building a short-term residential
  program for children and youth age 12-18. It is hoped that these programs will prevent many
  out-of-county hospitalizations and reduce hospital re-admissions.
   The Committee has long advocated for such programs, which broadens options for the
  continuum of care of children and youth.
- Received regular updates on the Continuum of Care Reform (CCR), which is an expansion of the "Katie A" initiative. Under this State-mandated program, Ventura County Behavioral Health and the Human Services Agency collaboratively provide mental health screening to all children entering the foster care system; when appropriate, short-term or ongoing services and treatment are provided.

- Received updates on the Suicide Prevention Committee, which meets monthly, and on other news and activities related to suicide prevention.
- Received updates on the state curriculum for parent partner certification. Once in place, the certification should help recruit parents.

The following presentations were given to the Committee throughout the year:

- Ventura County Behavioral Health Alcohol and Drug Programs services to teens. Based on medical necessity, these services include group counseling; some are offered on high schools campus. Clients are getting younger, and some are in the 6<sup>th</sup> grade.
- First 5. Each neighborhood for Learning focuses on early learning and family strengthening. Most services are free.
- Beacon Health Options, which contracts with Gold Coast Health Plan to provide mental health services to its members with mild to moderate impairment in mental, emotional or behavioral functioning.
- Mental Health Services Act (MHSA) overview, including how the funds are used: 80% for treatment and community support services, and 20% for prevention and early intervention.
