Presentation on 2-1-1 – Tanya Kellam, Director 2-1-1 provides information and referral to health and human services such as basic needs resources, physical and mental health resources, substance abuse services, and domestic violence resources. It operates 24 hours a day, 7 days a week. The line is staffed with well-trained employees who, after a brief screening, provide appropriate options for services. They may also suggest future services. In Ventura county, 2-1-1 is operated by Interface. It provides services to several additional counties. On a yearly average, it answers 20,000 calls from Ventura County residents. Callers can use a cell phone to call 2-1-1, although some VOIP and payas-you-go providers might not provide access to 2-1-1. Services are available in English and Spanish through bilingual staff, and 150 additional languages through phone interpretation services. | | D. VCBH Youth & Family Division updates – Susan Kelly VCBH continues to work on opening its own Crisis Stabilization Unit (CSU) for children, with the goal of opening in December. The County has a bid on a turn-key building. In the meantime, it is working cooperatively with CIRT to provide the best possible outcome for children in crisis. VCBH and HSA/CFS continue their partnership. CFS workers screen all children when they enter the foster care system and every six months or more often thereafter. They are referred to VCBH for mental health services as appropriate. Beginning July 1 st , these services will be expanded to the 0-5 population. | |
