

VENTURA COUNTY HEALTH CARE AGENCY

The Ventura County Health Care Agency is a fully integrated health care system emphasizing a continuum of care beginning with preventive health programs and emergency medical services, followed by acute inpatient care, and, when needed, continuing to lifelong case management services for chronic illnesses. Accessibility and quality of care are shared priorities for the Ventura County Board of Supervisors and the Ventura County Health Care Agency.

Hospitals & Clinics

Ventura County Medical Center

The Ventura County Medical Center is a full service, acute care hospital with state-of-the-art equipment and care. VCMC serves as the designated west county trauma center. High quality health care services are provided to all, especially the underserved, regardless of the ability to pay.

Santa Paula Hospital

Santa Paula Hospital, a campus of VCMC, is a community hospital providing compassionate, high quality health care for the residents of the Santa Clara Valley.

Ambulatory Care Clinics

Ambulatory Care Medical Clinics are a system of primary and specialty care clinics conveniently located throughout Ventura County.

Therapy Services

Therapy Services offers physical, occupational, speech-language pathology and hand therapy services.

Behavioral Health

Adult Mental Health Services

Adult Mental Health Services (clinic and field-based) are offered to individuals 18 to 65, countywide.

Youth & Family Mental Health Services

Youth and Family Services provide integrated services in the community, schools and clinics to children, teens and families.

Alcohol & Drug Programs

Ventura County Alcohol and Drug treatment for adults and youth offer a range of outpatient services designed to help individuals coping with substance use disorders.

DUI Programs

The Ventura County DUI Program offers a First Offender DUI Program and a Multiple Offender DUI Program for individuals convicted of driving under the influence. The program consists of education sessions, and group and individual counseling.

Public Health

Public Health Clinics

Public Health Clinics provide diagnostic and preventative services such as immunizations, HIV testing and TB testing & treatment.

Animal Services

Ventura County Animal Services protects the health, safety and welfare of animals and people in Ventura County by providing shelter, field and licensing services.

California Children's Services

CCS provides coordination and authorization of necessary medical services for children with eligible medical conditions when their families are unable to afford the services.

Emergency Medical Services

EMS is responsible for the development, coordination and oversight of the county-wide Emergency Medical Service delivery system.

Vital Records

Vital Record registers all births and deaths in Ventura County and issues the associated certificates.

Other Services

Ventura County Health Care Plan

The VCHCP is a licensed health care plan providing services to County of Ventura employees, their dependents, and Healthy Families members.

Medical Examiner

The Medical Examiner's Office has the responsibility to determine the circumstances, manner and cause of all deaths that result from suspected homicide, suicide, accident and /or suspicious or unexpected natural causes.

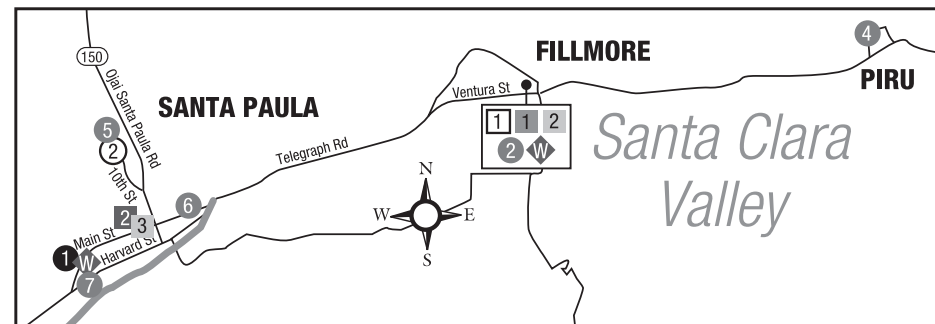
