Types of verifications which may be requested of the applicant and of their spouse (when applicable) include:

- California Driver License or ID
- Legal Permanent Resident Card (LPR/ Green Card)
- Social Security Numbers
- Denial Letter from the Social Security Administration for SSI/SSP
- Proof of income and property
- Sponsor's Information (if applicable)

## Cash Assistance Program for Immigrants (CAPI)

- Provides monthly cash benefits to aged, blind, or disabled non-citizens who are ineligible for SSI/SSP solely due to immigration status
- Recipients may also be eligible for CalFresh, Medi-Cal, and IHSS - a separate application must be completed for the above mentioned benefits
- 100% State Funded

## Who is Eligible for CAPI?

- Aged, blind or disabled non-citizens who are ineligible to receive SSI/SSP solely due to immigration status
- Resident of California
- Have resources below the allowable limits of \$2,000 for individual or \$3,000 for a couple
- Have income less than the applicable CAPI standards
- Additional requirements apply
