## Summary Fact Sheet - A Ventura County Perspective of Teledyne

- Teledyne Technologies Incorporated ("Teledyne") maintains its Corporate Headquarters at the Teledyne Scientific Company facility, Thousand Oaks, CA.
  - o Teledyne is a public company whose stock is traded on the New York Stock Exchange under the symbol "TDY".
  - o Teledyne is a leading provider of sophisticated instrumentation, digital imaging products and software, aerospace and defense electronics and engineered systems.
  - o Teledyne's operations are primarily located in the United States, Canada, the United Kingdom and Western and Northern Europe.
  - o Teledyne's 2014 annual revenues approximated \$2.4 billion.
  - o Teledyne employs approximately 9,300 employees worldwide.

- Teledyne Scientific & Imaging, LLC ("TS&I") is a wholly owned subsidiary of Teledyne Technologies Incorporated.
  - o Its two principal operating locations are located within Ventura County, one in Camarillo known as "Teledyne Imaging Sensors" and the other in Thousand Oaks known as "Teledyne Scientific Company", which is the subject of the permit being continued.
  - Teledyne Scientific Company is a research and development center for Teledyne's products and for a variety of customers, including the U.S. Government/U.S. Department of Defense.
  - o TS&I employs approximately 295 employees in Thousand Oaks, CA; total compensation of these employees exceeds \$42.1 million.
- Teledyne and TS&I employ in the aggregate approximately 385 employees at the Camarillo and Thousand Oaks, Ventura County locations, of which approximately 245 are located at the Teledyne Scientific Company, Thousand Oaks location (including approximately 70 persons at the Corporate Headquarters). Total compensation of these Ventura County-located employees exceed \$64.6 million. <sup>1</sup>
  - o Besides working in Ventura County, a substantial portion of these employees reside, pay real property taxes and shop in Ventura County, thereby supporting the region in a variety of ways.<sup>2</sup>
- Teledyne's operations support the employment needs and industrial, commercial and economic well-being of Ventura County.
