6.0 Ventura County Regional Strategic Workforce Development Plan

Cheryl Moore provided an update on the status of the reauthorization of the Workforce Innovation and Opportunity Act (WIOA). Reauthorization will focus more on aligning workforce development programs with sector, regional, economic development and education initiatives. New youth requirements will include a specification that 75% of allocated funds must be expended for out-of-school youth programs (up from the current 50%). WIOA will take effect on July 1, 2015. With draft guidelines and requirements expected to be issued in January 2015.
