For the most part, everyone is compliant with the FAA aeronautical use, local rules and regulations, and the lease agreements. Where we have identified issues, we are working cooperatively with tenants to correct them. There are less than 100 hangars that still need to be inspected, and we have sent out a certified letter to those tenants. Inspections only take a few minutes. Online Recurrent Drivers Training



Recurrent Airport Driver Training for the Department of Airports is now available online. You simply watch the instructional video and take a short exam. ADS-B Update

The FAA is working to raise awareness about equipping your aircraft with ADS-B Out. Starting January 1, 2020, you must be equipped with ADS-B Out to fly in most controlled airspace. Federal Regulations [14 CFR 91.225](#) and [14 CFR 91.227](#) contain the details. Find out how you should equip your aircraft depending on where you fly, what equipment has been FAA certified and other useful information. The FAA announced that they will offer a \$500 rebate on ADS-B installation this fall.

REBATE

To be eligible for a **REBATE**, your **aircraft** must meet these requirements

- Aircraft is U.S. registered
- Fixed-wing single-engine piston driven aircraft
- Aircraft not currently equipped with Version 2 ADS-B Out

Airports’ Capital Improvement Plan Schedule

The Airports’ Pavement Management Plans indicate that full reconstruction or major rehabilitation of runways and taxiways are due at both Camarillo and Oxnard Airports over the next Federal Fiscal Years (FFY). The department works closely with the FAA to program these projects based on available federal grant funding. The schedule below shows the proposed current years (subject to change).

Camarillo Airport

- FFY 2017: Development of the North-east Hangar Development, Phase I
- FFY 2021: Reconstruct/Rehabilitate RWY 8-26

Oxnard Airport

- FFY 2019: Reconstruct TWYs A, B, C, D, E
- FFY 2020: Reconstruct/Rehabilitate RWY 7-25
- FFY 2022: Reconstruct/Rehabilitate TWY F

Non-Grant Funded Projects for the County’s Fiscal Upcoming Year include:

- Solar Installations at both Airports
- Hangar electrical upgrades at two (2) County owned hangar rows at CMA

The Maintenance Corner

There is abundant maintenance activity at both Airports! With the recent hangar inspections, our work request load has multiplied 10 times the normal amount. While the increase in work requests is great for job security, it is tough to catch up on existing requests. The Department has experienced staff turnover in the past few months but we have recently recruited highly qualified personnel to join the maintenance ranks. We are working diligently to schedule and complete 100+ work orders generated as a result of being able to proactively look inside most County hangars. If you have outstanding work, we ask that you collaborate with us to schedule any hangar maintenance and please note that most requests require the aircraft to be out of the hangar. This process might take some time so we thank you in advance for your patience and understanding.

Camarillo Airport

- Everyone is reminded to please prevent tailgating through gates. We recently had another vehicle/gate accident that severely damaged Gate VI. The fact is 90% of accidents that occur at the gates are caused by tailgating. Please be respectful of others and don't follow too closely.
- It is once again, tree-trimming time, so please watch for vehicles and trimmers around the roads and business park areas.

Oxnard Airport

- We are looking to refurbish one hangar row (Hangar C-25 through C-36) in the July-September timeframe. This project is going to take a bit of time and more coordination between Airport Operations, Maintenance, and the affected tenants. We will be replacing most of the "skin" of the hangars while also working any structural issues.

Hazardous Waste Disposal Reminder

The used oil barrels at the wash rack are for individual use only. Leaving other items such as un-marked hazmat containers or large barrels resulting from commercial operations is not allowed. This behavior not only causes costly testing and disposal but could will result in hefty fines for those responsible.
