

## RAMP PROJECT NEAR SELF-SERVE FUEL ISLAND

The department will be rehabilitating the ramp area around the self-serve fuel island and along the front of the hangars to the east. This is a much needed project, but it will cause the self-serve pumps to be out of service from October 11 to the beginning of December. ## Taxiway Incursions Reminder

Remember - it is **NEVER** acceptable to walk or drive on the taxiway without permission from the tower, or the Department of Airports (outside of tower operating hours).

- Maintain awareness of your location in relation to the taxiway at all times.
- Ensure that guests are briefed on where the "restricted area" is in case they wander to look at aircraft or to find a restroom.
- If the driving lane is blocked, wait or go around on the street side, this is not an excuse to drive onto the taxiway (even by a few inches)
- BE OBSERVANT. If you see somebody about to accidentally stray onto the taxiway, educate them. Several incursions have occurred when an individual was walking backwards to get a "better shot" while photographing aircraft.

## Project's Happening at Camarillo Airport

Taxiway Edge Lighting – This project will be the conversion of the present stake mounted incandescent taxiway lights to can mounted LED taxiway lights. The project is scheduled to start on October 10.

Joint Seal Concrete Taxiways – This project is the completion of a multi year project to seal all of the joints in the concrete aprons and taxiways. There will be temporary closures of the taxiways with traffic having to be rerouted or back-taxed on the runway.

West Apron Rehabilitation Ph 2 – This project is the replacement of the west apron starting between tie-down rows 18 and 28. The contractor will start working on this area the week of October 9. Several aircraft are subject to relocation.

Hangar 1 & 2 Parking lots/ Houck & Post Streets Rehabilitation– This project is the rehabilitation of Houck and a portion of Post Streets as well as several parking lots along Durley Ave. The project is progressing well and we hope to have it completed soon.

## Project's Happening at Oxnard Airport

West Apron Slurry Seal and Perimeter Road Realignment – This project is the realignment of a portion of the perimeter road that dips down into the Runway Safety Area (RSA). The perimeter road and the west apron, in front of Executive Hangars West, will be slurry Sealed and striped. Project completion is the first week in November, with the slurry seal being applied on October 16 & 17.

Paid Parking Lot rehabilitation and landscaping – project is presently under design, planning to bid and construct after the rainy season.

## Reminders

- The small shed located at the wash rack is available for waste oil and filters. All other items left behind including batteries, paint, fuel, solvents, or any other chemicals other than oil jeopardize the program and result in possible fines and high hazardous materials cleanup charges.

- Airport dumpsters and trash cans are for airport generated waste only.
