## Camarillo

- Expect new payment coupon books for tenants at both airports in June. Rents have not changed!

- Asphalt ramp rehab in-and-around the wash rack and the area around CAF will be underway from May 6 to July 31.
- New hangars at the east end – LATEST UPDATE – the developer, APL, is preparing to submit plans. APL can be reached at 805-238-6801 for more information.
- The old Fire Station 50 has been demolished. The site is now being prepared to accept the 15 hangars that will be moved from north of taxiway "Foxtrot"
- The sewer upgrade project is nearing completion. Thank you for your patience with the interruptions and inconveniences caused by the work.
- Fire District's Headquarters remodel/addition is near completion. Watch for an official open-house announcement.

### ***Just a reminder that....***

- *Oxnard terminal parking is PRE-PAY for \$5 per day*
- *All other parking at the airports is limited to 72 hours without a permit.*
- *Fly at or above the PAPI glideslope (FAR Part 91.129)*
- *Miscellaneous storage around and behind hangars is not permitted.*
- *Open flame, welding, fueling is not permitted in non-commercial hangars (Fire Code and Airport Ordinance).*

## Oxnard

- Hangar #1 – The majority of the building is up, and construction continues. The lease with Million Air of Long Beach was approved by the Board of Supervisors and we anticipate occupancy in June '03.
- The perimeter road project has been completed. The result is a paved road that enables operations and maintenance staff to circumnavigate the airport without crossing the runway, with minimal wear and tear to the department vehicles.
- **Upcoming projects** include a runway surface rehab. This is scheduled for Fall of this year in conjunction with some ramp rehab. **The runway will be closed for approximately 4 days** during the project. We will provide a firm schedule for the closure as project plans are finalized.
- fifth Street drainage and street widening. Bids will be opened in April.
- Rental car parking lot project is in design. It will shift the rental cars to the south near the terminal. The County GSA managed project will reclaim area for transient aircraft parking.
