What's Happening at Camarillo Airport

- Ramp rehabilitation work continues in front of Channel Islands Aviation and Western Cardinal. New joint seal is being installed on the southern half of the concrete apron along with some new pavement in front of the restaurant. Phase II of this project (northern half of ramp) and the asphalt ramps at tiedown rows 1 and 2 (west of C&J Sales) and tiedown rows 25-29 (east of control tower) will be rehabilitated between July and December.
- East End Hangar Development The first two hangar buildings are up at the east end and two more are in plan check now. Occupancy of the first set of hangars is anticipated this Spring.

What's Happening at Oxnard Airport

- CP Aviation, a flight school operator from Santa Paula Airport, has set up shop in Hangar 2 at OXR as a subtenant of Million Air. We welcome CP and wish them continued success as a new operator at OXR while they deal with the Santa Paula limitations. - New security fencing will be installed along the east, south, and west perimeters of the airport. Construction is underway and should last approximately 2 months.

REMINDERS

- Animals must be under owners control AND please clean up after them!!
