**Hangar Maintenance** - Our Maintenance Division will be inspecting and replacing weather stripping on the doors of the County hangars in the mid-field area at Camarillo Airport.

**Dumpsters for Early Spring Cleaning** - To reduce weekly trash overflow on the airfield, large dumpsters will be located at both airfields in January. This is your opportunity to clean out your hangars. Airport related trash only. Dumpsters will be monitored for "cheaters". The airports are looking really good, your assistance to keep them that way is appreciated.

**Waste Oil Disposal** – Help us maintain our program. The small shed located at the wash rack is available for waste oil & filters, no other liquids or chemicals, keep the area neat. All other items left behind including batteries, paint, fuel, solvents, or other chemicals other than oil jeopardize the program. We need your cooperation to avoid fines and high hazardous material cleanup charges.

**How's Your Pattern?** A friendly reminder to be conscious of your pattern when arriving and departing the airports.

Camarillo - please avoid over flight of the noise sensitive areas to the north/northeast. Also, when flying an extended downwind to runway 26, please be aware of your altitude so you do not fly too low over the homes in the Village at the Park area.

Oxnard - please maintain proper altitudes and patterns to minimize the impact to the residents primarily to the south and the west towards the shoreline.

**Do not delay upon landing at CMA.** Remember to taxi your airplane well clear of the hold short bars after exiting the runway, especially on busy days. Failure to clear the hold bars may force another airplane to have to go around.

**Hangar Waiting List.** Please keep your information current on the hangar waiting list, including e-mail. This way when a hangar becomes available, we will be able to contact you in a timely manner.

**Be on the Lookout!** Skydivers are jumping approximately 5 miles NE of Camarillo Airport from 8000 feet. The landing zone is in Somis and is depicted on the Los Angeles Sectional Charts. Check NOTAMs and CMA ATIS on 126.02 or 805-484-3351 for real time activity. Jump announcements are being made at one minute to jump and at jump time over the control tower frequency on 128.2.

**Camarillo Airport Projects Update.** The paving project in the Key and Central ramps has been completed. Thanks to all who were relocated and otherwise inconvenienced.

### **Oxnard Airport Projects Update:**

The East Apron project is under way, this project includes the remediation of two LUFT sites left over from the military days.
