commented. EHD, Fire, Farm Advisor and Ag Dept representatives also commented. Conversation focused on Fire's desire for a 3 inch depth-of-spread and Ag Dept / Farm Advisor recognition that common ag-spread depths are 6-8 inches. Mr. Williams said that outside high fire hazard zones, which are mapped, the Fire Dept is willing to allow, upon application and consultation, but without a permit, up to 8 inch spread depths. The draft ordinance requires approval by the Ag Commissioner also, for depths over 3 inches. EHD sent notices of the draft ordinance to Agromin, Limoneira and Waste Management who are mulch providers in Ventura County. EHD intends to meet with Henry Gonzales as well as the Farm Bureau on this subject.
