- Allow time to fully coordinate actions between staff and ATAG. Move November 22 date to December 13, or further out, pending Draft 10 coordination with the Public Meeting.
- For ATAG members and stakeholders, identify problematic areas quantifiably;
   e.g., time, cost, practicality, impact to your operations, and financial planning considerations.
