15.2024 OVAC Goal Setting:

Anacker suggested a more comprehensive way to reach more community members, as it could be OVAC is not fully representing the community. The US Post Office EDDM – Everyday Direct Mail low-cost program could be used to mail up to 8.5 x 11 mailers with a lot of room for messaging on the mailer; he offered to get some quotes. Kennedy suggested the Lion's Club could help defray some costs by printing a Calendar with information on the OVAC.

- Burg: OVAC should focus on only three or four topics.
- Kennedy: OVAC should do a survey of Casitas Springs residents to learn of their needs. Also, work on low-income grants to help with 'after-school' programs that have helped children feel they belong to something and keep them "off the streets."
- Robles: Casitas Springs needs something more for their children, something cultural.

Perhaps hold a meeting of Oak View residents to get input on the situation. Install Stop signs or lights to help control traffic flow along Creek Road.
