**Chair Sunner allotted 3 minutes for public comment**

- *Kathy Navarro – Sochel announced an invitation along with flyers to the council to attend the “Resurrection of Honor” – a unique easter celebration hosted by the Rockbridge Vineyard Church. Day of event and location are Jose R. Flores Saticoy Community Center starting at 10AM thru 11:30 AM.*
- *Sierra Doehr announce an invitation to the council to attend the first Saticoy Farmer Market at the Boys and Girls Club Sunday, June 5, 2022, from 10:00 AM – 2:00PM – Seasonal Farmers Market first Sunday of the Month beginning in June thru October 2, 2022. Community Fridge will be offering donated items from Starbucks.*

VI. **Beat Report from County of Ventura Sheriff’s Office**

*Introduction of new Sheriff’s Office Captain Denise Sliva and Administration Sergeant Gilbert Gonzalez. A brief presentation about the Saticoy Beautification Event in which 7 members of the Sheriff’s Office volunteered their time to help Saticoy residents to get rid of their unwanted items. New Beat Officer from Sheriff’s Office, Julien Ferguson, will attend the May 2<sup>nd</sup> Saticoy MAC meeting to introduce himself and share his contact information with the community.*

**Questions/Comments from Council**

- *Council member Teri Hernandez asked about summary of items collected that day - - Summary of Collection was read out loud:  
Trash: 17.26 tons  
Metal: 3.24 tons  
Yard Waste: 2.1 tons  
**Total: 22.60 tons**  
Vehicle Count: 115  
E-waste Vehicle Count: 26  
That's an improvement over the last event in Saticoy in 2019 where 17.44 tons were collected from the community. **Nice work, Saticoy!***
- *Council member Jaqueline Flores commented on speed limits at Azahar St. to be very dangerous in the early morning hours when agricultural workers are trying to get to work – some drivers have been seen to drive parallel to railroad tracks at dangerous speeds.*
- *An invitation from council to review public traffic signs from County of Ventura Public Works Agency in the Saticoy area and a proposal on the need to install an appropriate public traffic sign at Azahar St. to help reduce the speed of drivers entering Saticoy.*
- *Councilmember Teri Hernandez questioned the ticketing process of abandoned cars around the community, it was stated, parked cars around the neighborhood have not moved – they have been abandoned on purpose or forgotten. This concern included RVs.*
- *Sheriff Captain Sliva stated she will connect/partner with CHP regarding Council’s speed traffic concerns – this will include to speak*

to Caltrans regarding jurisdiction between the County, CHP and Sheriff's Office.

**VII. Presentation from City of Ventura Planning Division**

- Neda Zayer, Community Development Director, City of Ventura presented to the Council the City of Ventura General Plan Process update and how it is related to the Saticoy area.
- Annexation of Saticoy to the city is a potential, the city is currently having conversations with staff.
- Ms. Zayer asked for contacts of Saticoy Leadership for community input
- Council brought up that the MAC was a great opportunity for Saticoy residents to listen to a presentation from the city and participate with input, questions, and concerns
