- *Andrew Huizar announced that Ventura County First Five will be hosting from Monday thru Friday their Parent and Children programming at the Jose Flores Community Center in the coming months to please help spread the word. Mr. Huizar handed out flyers.*
- *Breanne Alton from Pacific Coast Land Design announced that the City of Ventura is applying for a Caltrans Cycle 6 Area Transportation Plan Grant that would include the Saticoy Train Depot as a trail head. A 4 mile \$20M renovation project would help improve the connectivity of the Saticoy Area. Invitation to fill out an online survey to voice transportation needs in Saticoy was made and a link was shared.*

This is a "Call for Projects" from Caltrans – ATP Cycle 6, it is expected to include about \$650M made up of Federal, State, SB1, and State Highway Account Funding.*
