#### 2. Beat Report from County of Ventura Sheriff's Office

County of Ventura Sheriff's Office (VCSO), Deputy Sevelo reported no incidents of graffiti for the month of June.

Property Theft is on the rise as summer kicks off – advised the council to share with neighbors and advise them to take preventive measures to clear items from inside their vehicles and make sure they are locked. Deputy Sevelo introduced Sergeant Brian from VCSO, Homeless Unit, and made brief comments on the Unit's responsibilities and services provided, and contact information was provided through the homeless website at vchsa.org/help or calling 805-385-1800.

Receive and File a Presentation from the County of Ventura Human Services Agency Regarding Supportive Services in the County of Ventura Chris Russell, Senior Manager, Adult and Family Services, and Jillian Fleming, Homeless Services Program Manager from the County of Ventura Human Services Agency presented to the Council job responsibilities and services to the County's residents who are experiencing homelessness or are about to due to lack of funding to pay for rent, unitality, and household items with council members asking questions periodically. The main topic was to address the need for more staff to the Homeless Services Team. The motion was made by council member Terri Hernandez, and seconded by council member Jacqueline Flores and was carried by the council to draft an outreach letter to Supervisor LaVere to support more staffing to the Human Services Agency Homeless Services Team.
