- *Daniel Chavez, Co-Founder of the Saticoy Food Hub announced the Farmer's Market will be hosting at the Saticoy Park. He would like to discuss challenges regarding over booking the park to other patrons. He expressed that it is difficult for vendor and guest of the Farmer's Market to find parking with softball players and guests. Mention Food Pantry hours from the Food Hub Tuesdays – Fridays from 1P – 6PM, expressed that the Food Hub has fresh community farm eggs for Saticoy residents only.*
