Hi Maruja, I revised my comments below...thanks, Jeff

My comment/question concerns the proposed Road Diet (lane reduction) on Hwy 33 thru Oak View. Since the Demonstration Project, I have sat in traffic backed up 15 minutes from Oak View to Mira Monte driving west from Ojai to Ventura *in the morning going to work*, and backed up in traffic 10-15 minutes from Oak View to the 4-lane Hwy 33 driving east from Ventura *in the late afternoon returning home*.

People are now using alternate routes to Ventura, to avoid driving thru Oak View. On *Nextdoor*, I counted 111 responses about the Road Diet, 4 of which supported the lane reduction project. Most all comment they have never seen anyone riiding their bike.

As always, I have a conflict for the day and hour of the OVMAC meeting, so I am providing a written report for you from the Ojai Planning Commission:

Report from the City of Ojai Planning Commission on Activity Since the Last OVMAC Meeting (April 15, 2024)

- Late last year the City Council approved a Settlement Agreement with the Becker Group involving four parcels in the City; density for each site set by City Council. Two of those parcels that incorporate affordable housing units have now been approved or recommended for City Council approval by the Planning Commission: 304 South Montgomery (15 units, all affordable) and 510 E. Ojai Ave (5 units affordable of 13 total). One site located at 312 W Aliso received building permits recently; and the fourth (412 Mallory Way) is gearing up for public review and consideration.
- The Planning Commission recommended City Council approval of a project expanding the Lavender Inn hotel in downtown Ojai; the project would absorb an adjacent office building; convert it to hotel rooms; add a pool; and add storage buildings to the expanded parcel.
- The Planning Commission upheld the Planning Director's denial of a Temporary Use Permit (TUP) for an outdoor "Artists' Market" at the Ojai Women's Club. The applicant / sponsoring entity ("Conscious Collective") is not a non-profit organization and therefore not eligible to apply for the TUP. There were other issues related such as local businesses' objecting to 'unfair competition;' providing artists with a market; and the lack of imposed sales taxes (which local brick-and-mortar businesses do pay); but they were all moot due to the applicant's for-profit status.
- The Planning Commission recommended City Council approval of a text amendment to the Ojai Municipal Code regarding lot splits in residential zones under CA Senate Bill 9 (SB 9). This new law allows for lot splits and building up to a total of four residential units (primary homes, ADUs, and Junior ADUs). SB 9 allows for ministerial decisions (by City Staff, instead of by Planning Commission hearings) but with more restrictions on what size structures can be built and what size lot can be used.
