PUBLIC COMMENT

Any person who disrupts or impedes the orderly conduct of a meeting will be instructed to cease the disruptive conduct. Failure to do so may result in that person being removed from the meeting.

- a. **Applicant: Branden Dickey** - Application for a Box Truck, with dimensions of 11 Feet in Height and 16 Feet in Length. The truck is used for work purposes. The vehicle exceeds the height restriction, however, the ordinance includes a provision for work vehicles, if they can park next to the property. The application was incorrectly filled out using his work address, the permit is for 622 Wendy Dr., Newbury Park Ca, 91320. There does not appear to be additional parking on the property to park the work vehicle.

13. Status Report on Casa Conejo – Oversized Vehicle Signs & Permitting Process – Pulled to Regular Agenda by Scott Horn

Progress has been made since the approval of the resolution to ensure permitting exemptions and public notices can be made available. Additionally, we are working on the creation of a new phone number for locating of towed vehicles, reporting of vehicles in non-compliance and, the opportunity to apply for a permit online. 1) Presentation by Ventura County District Attorney, Erik Nasarenko

- a) The District Attorney spoke about organized crime from groups like the Chilean Theft Group. In 2022 his office prosecuted 65 first degree burglaries, down from 74 in 2021 and this year shows the numbers are even lower. He stated that people should keep areas well-lit and have cameras. Tuesday May 9th was National Fentanyl Awareness Day. The purpose is to bring attention the crisis that is before us as a nation. The drug is 50-100 more powerful than morphine. His office prosecuted 635 cases in 2022 and is advising drug dealers that they will bring 2nd degree murder charges for any death that is linked to them. He also stated there are no more recreational drugs, and that drugs purchased online including OxyContin, Norco, and other drugs are being laced with Fentanyl. There was a total of 270 overdose deaths in 2022 up from 116 in 2016 and 181 deaths had Fentanyl in the system. It a poison designed to kill people. Educating people is a big part of what his office is doing to let people know of the dangers. There are 2,907 open sexual assault cases in Ventura County. The District Attorney's office received a \$2.5 million dollar grant to purchase sexual assault kits and lab testing to help solve some of the cases that go back as far 1970. With the new technology they can help to identify perpetrators and get the data into CODUS database where the DNA can be matched up with other cases as well. Finally, District Attorney spoke about the Family Justice Centers in Ventura and Oxnard where people can go to a comfortable location to receive help, counseling and work with a detective assigned to the center to help people who have been assaulted, injured and in danger of being hurt. His office has motel and hotel vouchers, food cards, and other essentials to help people in need. He spoke about another Family Justice center being opened somewhere in East County as well to help people in need who are not able to drive to Ventura or Oxnard.

2) Status Report on Casa Conejo – Oversized Vehicle Signs & Permitting Process

- a) Field Representative, Israel Rodriguez provided an update and explanation on the delay of the instillation of the new signs for Oversized Vehicles. He explained that an QR code was being added to the sign, along with a new website that would make it

easier for people to scan the QR code on the sign and be able to apply for a permit online or find information on a vehicle that may have been towed. Israel Rodriguez explained that Casa Conejo would be the first community in the county to have "smart" signs and then the delay would be worth it in the future because of the enhanced features. It was then opened up to the public and MAC members for questions and comments. Generally, people understood the reason for the delay, although they expressed a desire to get the signs up quickly.

3) Casa Conejo Municipal Advisory Council to Adopt Conflict of Interest Code

Pursuant to Government Code section 87300, every agency shall adopt and promulgate a Conflict-of-Interest Code (COIC). The Ventura County Board of Supervisors is the code reviewing body for the Casa Conejo Municipal Advisory Council. Copies of the Conflict-of-Interest Code have been provided.

RECOMMENDATION TO APPROVE AND ADOPT

- a) Chair, Scott Horn spoke on the purpose of the Conflict-of-Interest Code a MAC members, and as a result the code needs to be adopted by the Casa Conejo MAC. - Debbie Hanna motioned to approve and adopt the Conflict-of-Interest Code, seconded by Debbie Hanna. Motion Passed.

4) 3-5 Year Plan – Next Steps

On, March 9th, the Casa Conejo MAC approved a motion to move forward on the 3-5 Year Plan. The next step is for the MAC to identify the key categories/components to include in the plan, such as crime, traffic, infrastructure issues, and opportunities for consideration in this meeting.

- a) Field Representative, Israel Rodriguez spoke on what is the next step and provided to samples of planning documents that provided a methodology on how to begin planning. The first document provided a series of open-ended questioned that were strategic or macro in nature. Examples of these questions were:
- What are the most pressing current issues Casa Conejo faces?
 - What issues does Casa Conejo face in the future?

Further discussion took place about narrowing the focus from strategic questions to talking about defining the scope of the plan and developing measurable goals and objectives. Field Representative, Israel Rodriguez then introduced another planning document, SWAT Analysis which is another way of planning and defining key issues along the line of what are Casa Conejo's strengths, weaknesses, opportunities, and threats? Questions and public comments were opened to include and open exchange about the planning process. Chair, Scott Horn spoke about the value of seeing the documents and how it helped frame the planning process. Other MAC members along

with public comment echoed the reinforcement of planning versus being reactionary. However, the chair felt with two MAC members absent and an open appointment that the topic be re-introduced and tabled for the next Casa Conejo MAC meeting in order for the other members to benefit from the discussion. The MAC members agreed and to include the planning discussion and documents for a future agenda item.

CALIFORNIA HIGHWAY PATROL

CHP MOORPARK'S CASA CONEJO MAC TALKING POINTS: (07.13.23)

- On Monday, June 26th, the CHP Moorpark Area started enforcing the new parking ordinance for oversized and recreational vehicles parked on the street within the Casa Conejo area. CHP Officer Ayers went door to door to residences that had vehicles in violation of this ordinance. The goal was to talk to the resident and explain the ordinance and answer any questions in person before taking any enforcement action. This process is ongoing as issues arise or violations are observed. As a reminder, this ordinance will take some time to gain 100% compliance. However, once compliance is met, it will be much easier and quicker to enforce. As it states in the ordinance, oversized and recreational vehicles can be parked on the street for up to 72 hours before any enforcement can be taken. Additionally, to be fair and equitable, the 72-hour clock starts when an officer sees the violation in person. Please be patient with the process.
- July is vehicle theft prevention month. CHP Moorpark will be conducting specialized operations and presentations throughout the county to help decrease auto theft and increase awareness throughout Ventura County.
- The California Highway Patrol conducted a Maximum Enforcement Period (MEP) over the Independence Day weekend. The MEP ran from Friday, June 30th through Tuesday, July 4th. The focus for this MEP was speed violations. Maximum Enforcement Periods have been a part of California Highway Patrol (CHP) policy for many years and have specific deployment and reporting procedures. During an MEP, field commands are required to deploy the maximum amount of uniformed personnel to address primary collision factor violations, impaired drivers, and assure a prompt response to any incident causing a hazard or traffic delay.
- The California Highway Patrol is hiring 1,000 officers to help make California's roadways safer. If you or someone you know would like to join the CHP, visit www.betheCHP1000.com for more information and to speak with a local recruiter.

- Four rescue ambulances are now in service, stationed in Simi Valley, Thousand Oaks, Camarillo and Santa Paula. They take the place of paramedic squads. The ambulances carry all the equipment that a paramedic squad does, and add the ability to transport patients to the hospital when the county's emergency response is experiencing high call volumes.
- Peak fire season is now underway, based on moisture measurements in vegetation. The heavy rains earlier this year supported a lot of new growth across the county. Many grasses have dried out and turned brown. All that extra growth could fuel for fast moving wildfires if there is an ignition.
- The deadline for completing fire hazard reduction measures was June 1. VCFD has completed inspections on nearly 90% of properties in the Fire Hazard Reduction Program area. Ventura County has a long history of great participation by residents. Those who have not completed all the appropriate steps will have an opportunity to correct those measures or the fire department will arrange for the work to be done and bill the property owner on their property taxes.
- VCFD is prepared for wildfires with three hand crews, our aviation unit and the upgrade to a CH-47 heavy helitanker based in Camarillo for the regional quick reaction force. The CH-47 helitanker can drop up to 3,000 gallons of water at once.
- VCFD will host three five-day sessions of Junior Fire Academy for girls and boys ages 13-16, starting July 17, 24 and 31 at the Regional Training Center in Camarillo.

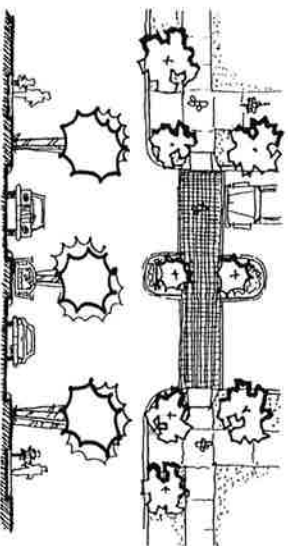

SPEED HUMPS/CUSHIONS



WHAT IS THE COUNTY'S POLICY REGARDING NEIGHBORHOOD TRAFFIC SPEEDING?

In July 2013, the Board of Supervisors approved a Speed Hump/Cushion Policy. The policy allows residents to install speed humps/cushions on some residential streets to address speeding and cut-through traffic concerns.

Speed humps/cushions often generate significant opposition. Therefore, speed-limit enforcement or monitoring by a radar trailer should be considered as a first option.

The County's Speed Hump/Cushion policy also stipulates the following:

- Speed humps/cushions are located in the travelway. Therefore, additions, alterations, or removals of any or all speed humps/cushions may occur at any time.
- Prior to the approval of new speed humps/cushions on any street, the County Traffic Engineer must request concurrence from the Ventura County Fire Protection District, the Sheriff's Department, and the California Highway Patrol within 20 calendar days.

- Speed hump/cushion construction costs must be paid by the property owners who sign the required petition.

WHERE CAN SPEED HUMPS/CUSHIONS BE INSTALLED?

Speed humps/cushions may be installed under the following conditions:

- If the location meets the warrants established by the Board of Supervisors;
- Upon receipt of the required petition or when the Road Commissioner (or an appointed designee) initiates the proposal; and

- The Board of Supervisors or the Road Commissioner (or an appointed designee) approves the request; and
- The speed humps/cushions are in conformance with the standard design in effect at the time of installation.

WHAT QUALIFYING CRITERIA DOES A COUNTY ROAD HAVE TO MEET TO BE COVERED BY THE COUNTY'S POLICY?

Requests for speed humps/cushions will be approved if all of the following criteria are met:

- The proposed location meets the requirements of a residential road or residence district as defined in Section 515 of the California Vehicle Code as follows: that portion of a highway and the property contiguous thereto, other than a business district, (a) upon one side of which highway, within a distance of a quarter of a mile, the contiguous property fronting thereon is occupied by 13 or more separate dwelling houses or business structures, or (b) upon both sides of which highway, collectively, within a distance of a quarter of a mile, the contiguous property fronting thereon is occupied by 16 or

more separate dwelling houses or business structures.

A residence district may be longer than one-quarter of a mile if the above ratio of separate dwelling houses or business structures to the length of the highway exists. The "residence district" determination shall be consistent with California Vehicle Code Section 240.

- A local road is defined for the purpose of this guideline as a road intended primarily to provide direct access to abutting residential buildings;
- The speed limit is 25 miles per hour or less;
- A speed survey shows that 67 percent of the motorists exceed the 25 mph speed limit;
- The road paved width is 40 feet or less and has no more than two traffic lanes;
- The average daily volume is greater than 1,000 vehicles in a 24-hour period;
- Speed humps/cushions cannot be installed on streets where the Road Commissioner has determined that they cannot

be safely installed due to severe horizontal or vertical curves, inadequate sight distance to enable drivers to see the humps/cushions, or excessive street downgrades.

- Speed humps/cushions will not be permitted on streets where the Road Commissioner determines that they will create equal or greater traffic problems by diverting traffic to nearby residential roads.
