PUBLIC COMMENT

Public comment is the opportunity for members of the public to participate in meetings by addressing the Santa Rosa Valley Municipal Advisory Council in connection with one or more agenda or non-agenda items. Public comments by a member of the public at a single meeting are limited to a cumulative total of five minutes at such meeting unless the time allotment is increased or decreased by the Chair depending on the number of speakers. The public comment period during the opening part of the meeting to address non-agenda items is limited to 30 minutes total for all speakers; this 30-minute limit does not apply to items on the agenda.

To maintain a public meeting environment conducive and welcoming to receiving public comments from all members of the public, the audience is discouraged from engaging in displays of support or opposition to staff reports or public comments, including clapping, yelling, booing, hissing or cheering, that may create a disruptive environment for members of the public wishing to participate. Any person who disrupts or impedes the orderly conduct of a meeting will be instructed to cease the disruptive conduct. Failure to do so may result in that person being removed from the meeting.

Members of the public who would like to augment their comments with visual or audio presentations must submit their materials to the israel.rodriguez@ventura.org for review at least 48 hours before the meeting. The review will be conducted to determine only whether the materials are on matters within the jurisdiction of the Municipal Advisory Council, would be disruptive of the meeting, or would foster illegality, such as identity

theft. If it is determined that materials are about matters not within the Municipal Advisory Council's jurisdiction, or would be disruptive of the meeting, or would foster illegality, use of County-provided equipment will not be allowed.

10. California Highway Patrol

- CHP Moorpark and the Moorpark Police Department will be hosting an open house event at our station on April 13th. This event will give the public a chance to see our station, checkout our patrol and special enforcement vehicles, and we will be holding a "bike rodeo" for new, young bicycle riders which will include a skills course and a helmet fitting station.
- The CHP Moorpark Area continues to send Special Enforcement Units (SEU) to conduct targeted patrols in Santa Rosa Valley, specifically targeting unsafe driving in the area surrounding Santa Rosa Technology Magnet School. Citations have been issued for unsafe turns, stop sign violations, unsafe speed, and various parking violations. Targeted patrols help saturate an area where multiple violations are known to be happening at once so multiple violations can be addressed in the area simultaneously.
- Using SEU's, Maximum Enforcement Periods, and daily proactive patrols, The California Highway Patrol has made significant strides in reducing the milage death rate (MDR), which is the number of lives lost in crashes per 100 million vehicle miles driven on California highways, and reducing

highway violence, specifically freeway shootings. The MDR dropped from 4,496 lives lost in 2022 to approximately 3000 lives lost in 2023. Additionally, freeway shootings dropped 25% in that same timeframe. We ALL need to do our part to continue this positive downward trend. **RECEIVE AND FILE**

11. Ventura County Fire Department

- The Ventura County Fire Department is supporting CalTrans and county Public Works as they work to clear debris from roadways closed by mudslides, including Highway 150.
- Fire Marshal Massoud Araghi retired after more than 35 years with the department. VCFD is interviewing finalists to succeed Araghi. Deputy Chief Chad Cook is serving as the interim Fire Marshal until a permanent successor is hired.
- Construction of the new Fire Station 34 in Thousand Oaks is expected to be complete in late June or early July. Construction of two new burn buildings and a ladder prop at VCFD's Regional Training Center is underway. That project is expected to be completed in March of 2025.

12. Ventura County Sheriff

- Residential Burglaries are still happening throughout the county. We recommend residents use our free Home Security Assessments to address ways to prevent them from becoming a victim of these crimes.
- Catalytic converter thefts continue to be an issue for residents in Ventura County. We have an "Etch and Catch" program where the vehicle's license plate is etched into the catalytic converters and a bright sheriff star is painted on it. This has become an effective deterrent to thieves that see this under the vehicle. Our Moorpark Sheriff's Department has the locations of body shops that are providing this free service.
- April 13, 11am-2pm, CHP and Moorpark PD are having an open house.

Welcome to the meeting of the Santa Rosa Valley Municipal Advisory Council (MAC) an advisory council for the unincorporated area of Santa Rosa Valley to Ventura County Supervisor Jeff Gorell.

OPENING

- 1. Call to Order.
 - Chair Rosemary Allison called the meeting to order at 6:00 PM
 - i. Due to a time constraint Deputy Rebecca Purnell was granted time by the Chair to make a quick presentation on the Sheriff's new Home Security Assessment Program. Residents can make an appointment for the Home Security Assessment team to come to their home and conduct a free security assessment. "Crime Prevention Through Environmental Design (CPTED) is designed to reduce victimization, deter offender decisions that precede criminal acts, build a sense of community among inhabitants so they can gain territorial control of areas, reduce crime, and minimize fear of crime."
 - ii. A flyer was provided for residents who are interested in signing up for a home assessment.
 - iii. Introduced Deputy Jon Nungester who will be our new lead coordinator with the SRV MAC.
- 2. Roll Call and Election of 2024 Officers.
 - All Members Present, Quorum Met
 - 2024 Election of Officers: **Kevin Cannon** nominates **Rosemary Allison** as Chair; **Mark Burley** seconded the motion. Motion Passes.
 - Vice Chair: Michael Adams nominates Amy Elliot as Vice Chair; Mark Burley seconded the motion. Motion Passes.
- 3. Pledge of Allegiance to the Flag of the United States of America.
- 4. Approval of the Minutes of the meeting of the Santa Rosa Valley Municipal Advisory Council held on Thursday, November 16, 2023.
 - Mark Burley motioned to Approve the November 16, 2023, minutes; Amy Elliot seconded the motion. Motion Passes
- 5. Agenda Review.
 - No Changes. Chair Rosemary Allison invited Safety Officers that were present to make brief verbal reports.
 - i. Sergeant Orr with the CHP Commercial Unit mentioned opening of the new scales is being delayed due to construction delays.
 - ii. He and his fellow officers continue to monitor commercial truck traffic on Santa Rosa Road to make sure that large trucks do not travel on this road.

- 6. Consent Agenda Items 10 through 13.
 - Mark Burley motioned to approve the Consent Agenda; Michael Adams seconded the motion. Motion Passes.
- 7. Office of Ventura County Supervisor Jeff Gorell's Comments Brief announcements and report on County activities.
 - **Supervisor Gorell** stated, note taken on Edison, I have met with the President of Edison and the issue of power outages is on their radar screen. I plan to bring in other legislators to help put pressure on Edison.
 - Storms from December have caused a lot of damage to the port, and around the county. The Board of Supervisors declared a State of Emergency.
 - Queensland Fruit Fly: If this spreads it could be devastating, The Agriculture Department is putting out traps and checking residential houses who have fruit trees. I am monitoring the situation closely.
 - Pit Count: Wednesday, January the 24th my office plans to help with the Point-In-Time (PIT) count of our unhoused population in our area.
 - The PIT count is very important to the county in determining resources, financial budgets, and is used in shaping policy regarding enforcement.
- 8. Public Comments Citizen presentations regarding Santa Rosa Valley Municipal Advisory Council related matters NOT appearing on this agenda. (See Guidelines above).
 - Collin Aska: Asked a question why his address on Blanchard was not reserviced/paved. Dave Fleisch from Public Works said he would investigate why Blanchard was not paved.
- 9. Council Comments -
 - Michael Adams: Spoke on power outages. Total of 59 hours that his
 power was down. He would like to bring Edison to talk about how they are
 not addressing the issue. Other counties have a detection system that
 shuts down the power automatically.
 - Mark Burley: Would like to thank Supervisor Gorell and his staff for providing information and assistance on Bridlewood Trail.
 - Chair Rosemary Allison:
 - i. For the Troops event. March 2nd Gala event. We are looking for auction items.
 - ii. Santa Rosa Valley resident artist Kimme Black, was commissioned to work on the bunnies you see around the county. Her bunny rendition is being unveiled tomorrow at 7:00 PM at the Conejo Players Theater on Moorpark Road.

10. California Highway Patrol

The California CHP concluded our annual CHiP's Kids for Toy Drive event this past month. Thousands of toys were distributed to kids throughout Ventura County. The California Highway Patrol conducted a Maximum Enforcement Period (MEP) over the holiday period with a focus on impaired drivers. The California Highway Patrol is hiring 1,000 officers to help make California Roads safer. Please see attached report.

11. Ventura County Fire Department

During heavy rains and storms in December VCFD responded to 231 weather related calls for service and is continuing to prepare for a heavily forecasted El Nino winter. Spark of Love delivered toys to 30,000 children and partnered with Foodshare to help 6,000 families with food during the holidays. In 2023 six Ventura County communities received their Firewise USA designation helping to reduce fires and make their neighborhoods safer. Approximately 40 communities have now started their Firewise certification process. The Ventura Fire Department completed the purchase of the new headquarters at 2400 Conejo Spectrum in Thousand Oaks. This ends a four-year search for a new headquarters. Applications for firefighter jobs will be accepted from January 22 to January 29, 2024.

14. Public Works to Provide Update on SRV Paving Situation

Representative from Public Works will provide an update on the recent concerns and solutions to the paving situation in Santa Rosa Valley.

- The paving contract is completed, and we are now looking at some of the concerns that have been raised.
 - We did not do a good job for setting expectation about the project
 - Two different treatments
 - Slurry Seal
 - Cape Seal plus a Slurry Seal
 - Concerns about loose gravel damaging cars. Public Works will continue to have the streets swept to remove the rock that keeps coming loose. Eventually the rocks will be gone.
 - The manholes and valve boxes will be raised to the level of the pavement.
 - Damage to your property. We will help in the process of filing a claim. We will help provide a list of contractors that can help remove the overspray or damaged areas.

Council Questions and Comments on the Re-Paving:

- o Michael Adams: Have you been sweeping the streets?
 - Answer: Yes, about every two weeks.
- Mark Burley: Asked if the contractor that was used previously had any issues or troubles. Concerned that you're forced to use the lowest bidder. If someone messes up, we should be forced to use the same contractor.

- Answer: We have not had problems before, and they have done fine. We must follow contract law. We do have the ability to bar them. Short of changing the contract code we must use the lowest bid.
- Kevin Cannon: Asked a question about inspectors that were used.
 Seems like there are inconsistent areas that the inspector missed.
- Rosemary Allison: Concerned about the amount of loose gravel that affects kids being able to play on the street or the danger it presents to kids falling. The County should be more aware of the surface.
 - Answer: We put a product down that we did not talk to you about. We should have done that.
- Supervisor Gorell: Will it get smoother over time?
 - Answer: The rocks coming up will go away, but it will not be smoother.
- o Kevin Cannon: Can we put another coat over the top?
 - Answer: It would not help.

Public Comments on the Repaving:

- Cristen: It was better before. Give us a heads up when the streets are being swept so we can move our cars.
- Collin Aska: I work with contractors. We usually go in between, so that we get quality work. I have seen so much gravel. Blanchard has a lot of potholes, so it was a good thing that it was skipped! I had a \$600.00 dollar bill from Edison. I feel that Edison is just a ripoff.
- Marcia Marino: Lived here 33 years. Worked for Homeland Security. The gravel is bad, and somebody is going to get hurt, and it has ruined my new car. It is just not safe for all of us.

15. Update for Public Works Requests – Santa Rosa Valley

For the month of December, a total of 5 requests were made using VCPWA Connect App, the Public Works online portal for reporting issues. Out of the 5 requests, a total of 4 have been closed out. Three of the requests involved road maintenance, one for illegal dumping and one reported a traffic-related issue. The app can be used to report issues such graffiti removal, potholes, waste management issues, and illegal dumping. Please refer online: VCPublicWorks.org or your app store and search VCPWA Connect. It is an effective way to solve issues and help your community.

16. <u>Update on Stepping Stones Contract and Status</u>

Colter Chisum – Deputy Director Ventura County Parks and Megan Shaffer - Founder Stepping Stones discussed the recent lease agreement with Santa Rosa Valley Park and plans going forward for use with the equestrian facilities. Colter Chisum: We love Santa Rosa Park. Reached out to us about a year ago and came to this MAC. Colter stated they are a great riding program. Terms of the lease is it a five-year pilot. Using an acre and half. For any large event they would have to file a permit as would be the case with any large event. The goal is to enhance the grounds. Better off with a partner like we have with baseball organization who use our parks and help maintain and improve the fields.

Megan Shaffer:

- The arena will remain public and not impacted by her program.
- Dragging schedule: My goal is to improve the footing of the ground for the horses. There has been no dragging that has been conducted other than what we have done in past.
- Concern about nitrates. Manure is picked up daily
- Park Use: We follow the Park hours set by the county. We will not impact hikers, bikers or people using trailers.
- Schedule: Home Schoolers in the morning and kids who go to public school ride in the afternoon.
- Security: There are cameras already and a park host is present.
- Turnouts & Lunging: We don't generally do lunging because the horses are older. They live in a herd fashion. No changes to turnouts or lunging. We do not jump our horses. Helmets are required.
- Colter Chisum mentioned the county parks are not paid by taxes but user fees. The park is underutilized. I am happy when I see anyone riding. It is a good thing. It is good to have groups partners with the county.

Council Comments on Stepping Stones Program:

- Amy Elliot: Worried about the safety of horses from people who might be going through the park with ill-intensions. Answer for Megan Shaffer: The Park host will be keeping an eye on the horses.
- Mark Burley: Wants to address those people who say that this process was done secretively. This project was first approved by the MAC in 2022 for 3 acres. Took a little while but we asked Megan to come back in December of 2023 to provide an update on the contract situation, and it may have caused confusion. This has been a process that has been ongoing. Mark provided some suggestions and comments on the program. It would be great to have a schedule for when lessons are occurring and allow for one of the rings to always be open to the public. He also

addressed the issue of turning and lunging horses. It is hard to enforce a policy that one group cannot do turnouts or lunging when several public riders practice that. He stated that minors should be required to wear helmets. He reinforced that Steppingstones is not a jumping program.

Mark Burley asked if anyone had seen people jumping their horses in the ring? People in attendance stated they have not. Mark also addressed the question of traffic. He feels that the traffic will be moving to a non-residential area, so he does not see this as a problem. He spoke about nitrites and how they come from several areas, farms, septic tanks, and ground water. The county created a formula where they determine how many horses can be a on property. Based on the county formula we could have 80 horses on these 50 acres and still be under the current nitrate formula.

• Chair Rosemary Allison: Concerned about the squishing of horses together and originally thought it was going to be 3 acres not 1.5 per the contract. Rosemary is also concerned about people not being able to use the arena with all the lessons being conducted. Colter spoke to the 3 acres versus the 1.5 acres and said the county would be open to more. Rosemary asked what is happening with pipe fencing? Megan stated that all fencing is going with me to the new location.

Public Comments on Stepping Stones Program:

- Patty Mayer: Competes internationally and stated the arena is in very good condition and does not require much more footing.
- Jen Price: I was the one on social media and was concerned about certain issues. One was that Megan would come back to explain the nitrate and other items before she signed a contract. There was a huge misunderstanding about the number of lessons. There was concern that the arena would always be in use by students. The number of lessons being performed turns out to be a lot less. The questions about nitrates were never answered by the county. We want this to work. Now that we know it is not 60 lessons a week it helps us to understand the program in a better light. She still had a few questions such as, who would drag the arena? How many horses are at a horse event? Magan stated according to the contract Stepping Stones will drag twice a month. The Park Host will drag once a week. Jen also stated It would help to post the hours of lessons.
- Darleen: We have nothing against the program, we just want to know more. I think you're doing a great thing. I feel people are throwing the dragging issue on you. She also felt that five years seems long for a trial period.
- Charlie Beck: Megan takes immaculate care of her facility. She drags her arena all the time. I don't see that being an issue. Traffic has never been a problem. Kids have never been a problem. She is a great neighbor, and I will be sad that she is going. It has been fun watching the kids and I respect the fact she has never had a horse get out.

- Helan: Will you be using poison for rat control Megan Answered Never. When will you remove manure? Megan Answered – Daily.
- Colter Chisum talked about revenue for the park. We generally run at
 a loss, but the use of the arena helps justify and enhance the park. The
 park was never in danger of closing, but it was considered under used.

- CHP Moorpark and the Moorpark Police Department (Ventura County Sheriff) will be hosting an open house event at our station on April 13th. This event will give the public a chance to see our station, checkout our patrol and special enforcement vehicles, and we will be holding a "bike rodeo" for new, young bicycle riders which will include a skills course and a helmet fitting station. We look forward to seeing you and your families at this fun event.
- The CHP Moorpark Area continues to send Special Enforcement Units (SEU) to conduct targeted patrol in the Santa Rosa
 Valley, specifically targeting unsafe driving during commute hours. Citations have been issued for distracted driving, unsafe
 turns, unsafe passing, unsafe speed, and various parking violations. Targeted patrols help saturate an area where multiple
 violations are known to be happening at once so multiple violations can be addressed in the area simultaneously.
- Through the use of SEU's, Maximum Enforcement Periods, and daily proactive patrols, The California Highway Patrol has
 made significant strides in reducing the milage death rate (MDR), which is the number of lives lost in crashes per 100 million
 vehicle miles driven on California highways, and reducing highway violence, specifically freeway shootings. The MDR
 dropped from 4,496 lives lost in 2022 to approximately 3000 lives lost in 2023. Additionally, freeway shootings dropped
 25% in that same timeframe. We ALL need to do our part to continue this positive downward trend.
- The California Highway Patrol is hiring 1,000 officers to help make California's roadways safer. If you or someone you know
 would like to join the CHP, visit www.betheCHP3000.com for more information and to speak with a local recruiter. Also,
 the CHP is hiring more than JUST officers. We are currently looking to fill 165 dispatcher vacancies across the state and are
 also looking for Commercial Vehicle Inspection Specialists to inspect the growing number of commercial vehicles on
 California highways. The CHP will provide you with the training for all three of these positions. More details and

- The Ventura County Fire Department is supporting CalTrans and county Public Works as they work to clear debris from roadways closed by mudslides, including Highway 150. VCFD is working with county EMS on a coverage plan for cut off areas.
- Fire Marshal Massoud Araghi retired after more than 35 years with the department. VCFD is interviewing finalists to succeed Araghi. Deputy Chief Chad Cook is serving as the interim Fire Marshal until a permanent successor is hired.
- Construction of new Fire Station 34 in Thousand Oaks is expected to be complete in late June or early July.
- Construction of two new burn buildings and a ladder prop at VCFD's Regional Training Center is underway. That project is expected to be completed in March of 2025.
- Construction of a new Fire Station 29 in Santa Paula will go out to bid March 13. A contract is scheduled to be awarded April 23 and the tentative start for construction is May 21.



MEETING MINUTES Monday, January 30, 2024 at 3:30 p.m.

Rancho Santa Rosa Property Owners' Clubhouse 11701 East Las Posas Road Santa Rosa Valley, CA 93012

- 1. Call to Order The meeting was called to order at 330pm, and 2 members of the committee were present. Also present was Max Young from the Ventura County Regional Firesafe Council.
- 2. Agenda review
- 3. Approval of minutes from 11/20/2023 **MOTION** to Approve the minutes passed unanimously.
- 4. Report from Kevin on Firewise happenings since our last meeting -
 - Both Ed Spafford and Joe Stayton resigned from the committee. After many attempts to contact Ed with no response, he finally emailed his resignation the same day that our SRV MAC presentation was to have occurred on 1/18/24. His stated reason was he did "not feel right endorsing this program on this scale." Joe resigned verbally just prior to our 1/30/24 committee meeting with the reason "it's just not my thing." Our committee can continue with only 3 members as Firewise USA requires 3 to 5 member committees.
 - Cheryl Crandell from A Diamond Association Management was contacted to see if Wildwood
 had made any decision yet to opt out. She relayed Ed presented Firewise options at their 1/22
 Board meeting, but no final decision had been made at that time. Ed's recommendation to the
 Board was to opt out of SRV Firewise and consider starting their own effort.
 - Max Young confirmed that our committee has his full support in proceeding with our plan to
 designate the SRV MAC boundary as our official boundary for the SRV Firewise Community.
 NOTE Natasha Saxena has taken on the official role of Firewise Regional Coordinator and will
 also assist us as much as possible.
 - Kevin reported he attended the first monthly Zoom meeting hosted by the Ventura Regional
 Fire Safe Council. Their web site has been updated and contains a wealth of great information
 including a summary of the steps, FAQs with concise answers, required forms including
 samples, and a map detailing both recognized and proposed Firewise Communities. SRV
 Firewise is shown on the map and proposed to include the entire SRV MAC boundary.
 - An account has been created for SRV Firewise on the national Firewise USA Application portal.
 Only our committee members' names and contact information has been entered so far. Kevin is designated as the community's point-of-contact (POC) member.
- 5. Report from Joe Stayton on discussions with Rancho Santa Rosa POA Board Prior to the meeting Joe told Kevin that he provided our draft HOA invite letter to the Rancho Santa Rosa POA Board at their recent meeting and that POA President Patty Mayer was still interested in participating in Firewise. Kevin to follow up with Patty. NOTE Mark Roddy reported after the meeting that the Santa Rosa Highlands Board has confirmed their association's participation in SRV Firewise.
- 6. Review of formal letter to be sent out to all SRV HOA Boards It was decided to edit the letter to deemphasize the promise of immediate insurance premium discounts as a reason to participate. Instead, we will promote a "neighborhood helping neighborhood" notion that will gradually reduce our overall wildfire risk for the entire SRV community. We should also provide a good strategy for demystifying the complexity of the program and dispelling the notion that documenting enough

- volunteer hours/efforts to maintain our recognition will be difficult year after year.
- 7. Report from Eric on website progress No further progress was reported. Eric is working on creating the website separate from the GoDaddy shell currently in place at srvisfirewise.org. NOTE The GoDaddy shell is collecting subscriptions, i.e. email addresses, but I'm not sure where those addresses can be retrieved from. Therefore, we should not be promoting our website until Eric can at least get email collection and recovery functionality implemented on his replacement website.
- 8. Review of SRV Firewise presentation given at the 1/18 MAC meeting The MAC meeting ran long that night and Kevin was not able to make the formal presentation. However, our November 20th meeting minutes were included near the bottom of the full agenda packet posted on Jeff Gorell's website here:
 https://vcportal.ventura.org/BOS/District2/SantaRosaValley/docs/meeting/SRVMAC_2024-01-18 agenda amended.pdf Kevin will for sure present at the March 21st MAC meeting and provide SRV Firewise "updates" at all subsequent MAC meetings. NOTE Every amount of time we spend discussing SRV Firewise publicly will count towards our volunteer hours once the we start the clock.
- 9. Wildfire risk assessment strategy discussion -
 - We discussed creating our boundary again using either the old or the new MAC boundary. The
 new MAC boundary adds 3 undeveloped parcels within 3 additional political precincts, namely
 Gabbert 2-004, 2-005, and 2-006. Max suggested we include all 3 of these new precincts to
 avoid having our Firewise boundary line cut a parcel boundary in two. Given that some portions
 of the parcels are accessible from Hitch Blvd and behind the locked residential gate at the west
 end of Presilla Rd, it could also provide help us develop potential emergency egress routes.
 - Max offered to create a new detailed map that outlines each of the SRV HOAs that lie within our SRV Firewise Community to gain a better handle on where each of our "neighborhoods" reside. Neighborhoods that are not part of an HOA could also be given names and designated on our community map.
 - Our strategy for collecting risk assessment data can start initially by identifying a POC for each neighborhood that is willing to participate. A statistical analysis of each neighborhood's characteristics would suffice as opposed to a 100% inventory. Once individual neighborhood data is determined it would then be rolled up into the summary report format that is required by the Wildfire Risk Assessment template section within the Firewise USA application submittal.

10. Action Items

- Kevin to contact Patty Mayer regarding Rancho Santa Rosa POA's participation.
- Kevin to follow up with Cheryl Crandell to gain other HOA contact info. Note A Diamond Association Management currently manages 8 of the 12 SRV HOAs.
- Eric to continue website development.
- Max and Kevin to refine our SRV Firewise Community map further delineating as many neighborhoods as possible before the March 21st MAC meeting.
- Kevin to refine the HOA invitation letter to be sent to all HOA Boards.
- If we can identify enough neighborhood POCs before the end of February Kevin to propose an educational Firewise Outreach meeting to all interested individuals for the 2nd week of March, possible 3/14. We should at least try to have our next committee meeting that week.
- Kevin to provide a SRV Firewise presentation at the March 21st MAC meeting.
