11. Ventura County Fire Department

This month, Ventura County experienced its first large fire of the year. The Mountain Fire burned more than 20,000 acres, destroyed nearly 200 homes in Camarillo and forced hundreds of residents to evacuate. The Ventura County Fire Department was supported by numerous agencies from across the state in responding to the fire. Those efforts are still underway at the time of this report. We are grateful for their assistance.

- A Local Assistance Center was being set up to guide residents and businesses affected by the fire through the recovery process and share information about assistance that might be available. Additional information will be available at vcrecovers.com.
- Once conditions enabled property owners to return to their properties, eight Community Patrols were established to assist in sorting through the remains of burned homes for items that might have survived. Those firefighters wore

personal protective equipment so they could work safely in the ash and debris, which also allowed the property owners to stay safe.

- Additional Santa Ana wind events are bound to happen. Everyone should remain vigilant about avoiding activities that could start a fire, such as a hot muffler against tall weeds, a dragging tow chain, a tossed cigarette or an outdoor fire pit.

12. Ventura County Sheriff- Mountain Fire Damage Report

INCIDENT SUMMARY

- On 11/15/2024, Cal Fire Incident Management Team 5 demobilized and transitioned full command of the incident back to the Ventura County Fire Department.
- As of this evening, updated mapping of the fire revealed a reduction in size to 19,904 acres with 91% containment.
- Ventura County Fire Personnel will continue mop-up work over the next week to achieve 100% containment.

WATERSHED ASSESSMENT

- Personnel from the California Conservation Corp have been requested to support a Watershed Protection Mission. The purpose of this mission will be to place erosion control devices on parcels with destroyed structures to prevent runoff and/or containment during a rain event. Equipment and crews are being mobilized and will begin work soon.
- The Cal Fire Watershed Emergency Response Team continues to gather data on impacts the fire has caused to the local watershed. This report will take several weeks to produce.
- Several local agencies will assemble the first week of December to complete a local watershed assessment. The purpose of this assessment is to better understand the post-fire debris flow risk, determine mitigation strategies and create evacuation plans.

OTHER RECOVERY EFFORTS

- On 11/19 & 11/20, Ventura County Sheriff Emergency Services, Cal OES & the Small Business Administration personnel will be working jointly to verify reported damage to residential structures. The goal of this verification is to qualify Ventura County Residents and businesses for loan interest SBA loans.
- A total of 149 fire survivors have visited the Local Assistance Center (LAC) that opened on Thursday, November 14, 2024, at the Ventura County Office of Education in Camarillo. The LAC will continue to operate Monday-Saturday from 9am-7pm for residents and business owners impacted by the Mountain Fire to able to access recovery services.
- County and City of Camarillo staff continue to develop plans for a comprehensive debris removal program that will be made available to property owners with destroyed structures.

 - Motion to accept the July 18, 2024, Minutes with corrections made by **Mark Burley**, seconded by **Kevin Canon**. Motion passes.
 - i. **Mark Burley**: Correction to item 15 of the minutes: "Change to local residents to make pies."

- ii. **Kevin Canon** Correction on Item 15 make the change to from “Precinct Captain” to “Resident Leader.”

5. Agenda Review.

- Asked for Item #16 on the agenda, Presentation from Toll Brothers on the Santa Rosa Valley Estates to be moved to the front of the Regular Agenda.
- Asked for Item #15 Update from Verizon Generator at Vista Arroyo and Santa Rosa Road to be moved to the second item on the Regular Agenda.

6. Consent Agenda Items 10 through 12.

- Motion to accept the Consent Agenda Items 10-12 made by **Mark Burley**, seconded by **Chair Rosemary Allison**. Motion passes.

7. Public Comments:

- Walt and Vicky Smith spoke on Item 14 the Verizon Generator. Spoke on AB2421 requirements for emergency generator and the issues of public notification, public right-of-way, and hazards to the public due to the Verizon generator.
- Greg Reagan spoke on the issues concerning the Verizon generator and on the addition of the bicycle lane. He feels encouraging more cyclists to use the road is more hazardous because of the speed of vehicles. He suggested that bikes be banned from the Norwegian Grade.

8. Office of Ventura County Supervisor Jeff Gorell’s Comments –

- **Supervisor Gorell** announced the Fire Insurance Town Hall that he is co-hosting with Assembly Member Irwin and Deputy Insurance Commissioner. The panel includes members from Ventura County Fire, Fire Safe Council, and subject matter experts from the real estate, insurance and mortgage industries, including our very own Rosemary Allison. The topics include ways to protect your home and communities from wildfire, and strategies for renewing your fire insurance.
- We have new Director of Public Works and is working with our office to create a communication tool and solution to informing our team and constituents of when work is being done ahead of time.

10. California Highway Patrol

- The CHP Moorpark Area continues to send Special Enforcement Units (SEU) to conduct targeted patrols throughout the Santa Rosa Valley. Citations are being issued for unsafe turns, unsafe passing, posted signage violations, unsafe speed, and various parking violations. Targeted patrols help saturate an area where multiple violations are known to be happening at once so multiple violations can be addressed in the area simultaneously.
- CHP Moorpark is hosting a Start Smart class on **Thursday, September 26th from 6:00pm-8:00pm** at the Moorpark CHP Office at 610 Spring Rd. in Moorpark. This is a FREE class offered to current and prospective teenage drivers and their parents/guardians to discuss important issues such as tips on how to avoid crashes, safe driving habits, dynamics of a crash, consequences of a poor choice behind the wheel, parental roles and responsibilities, and legal and civil liabilities. - CHP Moorpark will be at several upcoming community events:

 - Make'm Smile, celebrating kids with special needs on **Saturday, September 28th from 11:00am-3:00pm** at America's Teaching Zoo at Moorpark College.
- The California Highway Patrol is hiring 1,000 officers to help make California's roadways safer. If you or someone you know would like to join the CHP, visit www.betheCHP1000.com for more information and to speak with a local recruiter. Also, the CHP is hiring more than JUST officers. We are currently looking to fill 165 dispatcher vacancies across the state and are also looking for Commercial Vehicle Inspection Specialists to inspect the growing number of

11. Ventura County Fire Department

- The VCFD has been contacted regarding the status of a radio communication tower that was planned for Fire Station 36 located in Oak Park. After careful consideration, we have decided not to pursue this project at the moment. Currently, we are focused on rebuilding our communications microwave system and enhancing our VHF radio capabilities. This work is integral as we evaluate all available options for our radio infrastructure's future. The tower project was intended to improve our existing system but given the ongoing design and study of the new system requirements, we are pausing the tower and other similar projects at selected locations. Additionally, we are in the process of evaluating our staffing needs, including the potential hiring of a new department IT/Radio positions following the recent departure of our previous manager as well as a Telecom Analyst. These potential new hires will play a crucial role in aligning our current and future needs to ensure we develop adequate infrastructure. Thank you for your understanding and continued support in our public safety systems.
- October 6-12 will be Fire Prevention Week. This year's theme is Smoke Alarms, Make Them Work for You. VCFD will be challenging residents to share the safety message by posting short videos of creative ways to test your smoke alarm to social media. Participants in the smoke alarm challenge could win a VIP experience with an engine company or a fire extinguisher. Start developing your ideas now. We want to see how you complete the Smoke Alarm Challenge.
- Fire conditions are high across California. VCFD firefighters have been deployed as mutual aid to many other communities this summer to help stop large wildfires, just as other agencies responded to help us on several occasions earlier this summer. That fire activity is a reminder to continue vegetation management on your property and maintain safety practices. A spark from a dragging chain on a trailer, a tossed cigarette or a hot muffler against a dry weed might be all it takes for the next fire to start. **FILE AND RECEIVE**

13. Update on the New Santa Rosa Valley Estates Development

- **Bill McReynolds, Vice President of Land Acquisition for Toll Brothers** provided an update and presentation on the new Santa Rosa Valley Estates development which is scheduled to break ground in the December or January timeframe. **RECEIVED & FILED**

14. Update on the Verizon Generator at Vista Arroyo and Santa Rosa Road.

Public Works Deputy Director Anitha Balan provided a background on the Verizon Generator project.

- Because there was an existing Verizon utility equipment/footprint at the location there was not a need to notify the public or receive pre-approval for the addition of the Verizon Bunker and generator.
- Due to complaints that have been received about Verizon workers having to cross over private property (Bridlewood Trail) to access the bunker, the access doors are being changed to access the bunker from the Santa Rosa Road side.
- **Chair Rosemary Allison** asked about the noise factor that presents a potential danger.
- Anitha Balan stated that it is only an emergency generator and will be operational all the time.
- **Mark Burley** asked if she knew what the set-back for a building such as this from a private party. Anitha Balan was unaware what the set-back is and said she would get back with that information.
- A member from the audience referred to Assembly Bill AB2421 requires only 250 cubic feet, and that this generator represents 550 cubic feet and wanted to know how it is justified. **Supervisor Gorell** stated that our office will follow-up.

Verizon Team Introduced:

Michelle Brower – Verizon Municipal Engagement Team

- The question of AB2421 was brought up. **Jesus Roman** stated that no rules have been waived as far as he knows. As far as Verizon could tell they met the requirements. The existing facility was already there and underground. The discussion of public notification came up and everyone agreed that if public notification would have been done it would have been better. Verizon agreed that with public notification the generator could have possibly been moved closer to the road.

- Verizon indicated that during construction they did not know they were encroaching on private property, and it was believed there was a right of way for this unit. That is why they are here today to talk about relocating the access doors so that they do not violate private property.
- **Mark Burley** asked Verizon if they knew what the set back is for this type of facility. Michelle from Verizon stated that she could not quote the County code for the set back.
- **Mark Adams** asked about moving the vault to a different location. Verizon answered by stating that the generator is currently in operation and there is quite a bit of underground work in the right of way located next to the telecommunication located in the vault.
- **Supervisor Gorell** asked if moving the generator closer to the road would satisfy equestrian User/needs or is it a solution that satisfies no-one? Verizon answered said moving it would be a challenge and we have been talking with Public Works about changing the access to help solve the issue.
- **Mark Burley** said that he believes that it could have been moved further back it could be away from the trail and could still function. If it would have it come up from the very beginning with the land owners and the MAC, I think it would be in a different place and not two inches from private property.
- **Supervisor Gorell** asked if there have been injuries, have horses been taken to the vet so that we can get an idea of the magnitude of the problem. A member from the audience mentioned that when you are riding a 1,200-pound animal and if that horse gets spooked the animal can end up in the middle of Santa Rosa Road causing harm to the horse and the rider.
- **Michelle Bower** from Verizon spoke to the noise issues. The generator was built for public safety during fire shut offs (PSPS) so that the public can stay connected. The only time other than emergency shut-off the generator would only be run for once-a-week maintenance for ten minutes and we could set a weekly time for that maintenance to be conducted. We can look at ways to add materials to lower the noise factor.
- **Kevin Canon** asked if a safety light can be installed as a visual que to warn riders before the generator goes off.
- **Supervisor Gorell** asked what further noise mitigation steps can be added. Verizon talked about adding vines and padding inside the walls. It was also mentioned that the generator meets the requirements of the law.
- **Michael Adams** stated that while it may meet the requirements, it is an issue of a horse passing 5 feet away from the generator is the issue. He stated that the suggestions from Supervisor Gorell and Kevin Canon made a lot of sense.

- **Chair Rosemary Allison** suggested that we set up a meeting with Verizon the HOA and the home owner located next to the generator. Verizon stated they do want to make it right with the community. We can address the aesthetics and the access.
- **Supervisor Gorell** stated that he is tasking his office with taking on this issue and providing solutions which include noise mitigation, moving the access doors, implementing visual cues, and servicing the generator.

15. Update on Santa Rosa Valley Fall Harvest

Vice Chair, Amy Elliott will provide an update on the upcoming SRV Fall Festival that will take place on October 26, 2024, in partnership with Ventura County District 2 Office and Stepping Stones Riding Program.

- The event will take place at Santa Rosa Park
- Proceeds from vendor fees, pie auction, and drinks will benefit Stepping Stones.
- Look for people to make pies that we can auction off. Assemblymember Irwin will be making a pie.
- The event is meant to create community spirit.

16. Update on the New MAC Structure for 2025

Supervisor Gorell's Chief of Staff, Ashley Bautista and **Field Representative, Israel Rodriguez** presented potentially new MAC Structure for 2025.

- The goal is to accomplish more objectives and involve more people.
- The new structure proposes that a 2025 plan be in-line with the state mandate with goals and objectives in the areas of:
 - Public Health & Safety
 - Planning & Public Works
 - Community Relations or Welfare
- The proposal is to move to quarterly meetings to be supplemented by more ad-hoc committees to achieve the goals and objectives set by the MAC in the above-mentioned areas.
- MAC members will select which sub-committee they want to serve on and which ad-hoc committees they will be involved in.
- Because ad-hoc committees are project driven they do not come under the Brown Act. The new structure allows the Sub-Committees to set strategic goals and objectives with the flexibility of the ad-hoc committees to implement the goals and objectives.
- Ad-hoc committees also allow the flexibility of meetings taking place online or in peoples homes without having to post an agenda or take minutes.

- **Amy Elliott** asked about how to keep the momentum going between quarterly meetings. **Israel Rodriguez** stated that we will be having more meetings with the addition of the ad-hoc committees and generate more excitement by people getting involved in ad-hoc committees.
- Discussion took place and it was suggested that we keep the current bi-monthly meetings.
- **Kevin Canon** made the point that our boundaries have been expanded and that more people are now included in the MAC.
- Discussion took place around the frequency of the meetings and the MAC members stated they would like to stay with bi-monthly meetings.
- **Rosemary Allison** motioned that we go to quarterly meetings with the addition of ad-hoc committees. The motion was not seconded and did not carry.

- This month, Ventura County experienced its first large fire of the year. The Mountain Fire burned more than 20,000 acres, destroyed nearly 200 homes in Camarillo and forced hundreds of residents to evacuate. The Ventura County Fire Department was supported by numerous agencies from across the state in responding to the fire. Those efforts are still underway at the time of this report. We are grateful for their assistance.
- A Local Assistance Center was being set up to guide residents and businesses affected by the fire through the recovery process and share information about assistance that might be available. Additional information will be available at vcrecovers.com.
- Once conditions enabled property owners to return to their properties, eight Community Patrols were established to assist in sorting through the remains of burned homes for items that might have survived. Those firefighters wore personal protective equipment so they could work safely in the ash and debris, which also allowed the property owners to stay safe.
- Additional Santa Ana wind events are bound to happen. Everyone should remain vigilant about avoiding activities that could start a fire, such as a hot muffler against tall weeds, a dragging tow chain, a tossed cigarette or an outdoor fire pit.

- On 11/15/2024, Cal Fire Incident Management Team 5 demobilized and transitioned full command of the incident back to the Ventura County Fire Department.
- As of this evening, updated mapping of the fire revealed a reduction in size to 19,904 acres with 91% containment.
- Ventura County Fire Personnel will continue mop-up work over the next week to achieve 100% containment.

WATERSHED ASSESSMENT

- Personnel from the California Conservation Corp have been requested to support a Watershed Protection Mission. The purpose of this mission will be to place erosion control devices on parcels with destroyed structures to prevent runoff and/or containment during a rain event. Equipment and crews are being mobilized and will begin work soon.
- The Cal Fire Watershed Emergency Response Team continues to gather data on impacts the fire has caused to the local watershed. This report will take several weeks to produce.
- Several local agencies will assemble the first week of December to complete a local watershed assessment. The purpose of this assessment is to better understand the post-fire debris flow risk, determine mitigation strategies and create evacuation plans.

OTHER RECOVERY EFFORTS

- On 11/19 & 11/20, Ventura County Sheriff Emergency Services, Cal OES & the Small Business Administration personnel will be working jointly to verify reported damage to residential structures. The goal of this verification is to qualify Ventura County Residents and businesses for loan interest SBA loans.
- A total of 149 fire survivors have visited the Local Assistance Center (LAC) that opened on Thursday, November 14, 2024, at the Ventura County Office of Education in Camarillo. The LAC will continue to operate Monday-Saturday from 9am-7pm for residents and business owners impacted by the Mountain Fire to able to access recovery services.
- County and City of Camarillo staff continue to develop plans for a comprehensive debris removal program that will be made available to property owners with destroyed structures.
