What is Firewise USA?

- Firewise USA is a National "Grassroots" Program administered by the National Fire Protection Association (NFPA)
- Free and voluntary Does not require 501c3 status to operate
- No regulation or enforcement involved
- More than 1,900 communities across the country (~900 in CA)
- Credited with multiple instances of prevented structure-loss






What is the program's objective?

 Firewise USA provides the collaborative framework to help a community and its neighbors organize, find direction, and take action to increase its resilience to wildfire

The number of residential property insurance companies offering insurance discounts for fire-hardened homes and communities has increased since Commissioner Lara took office in 2019. Several companies offer both community-wide discounts (for example, a home in a Firewise or a Shelter-In-Place community) and home-specific discounts (for example, maintaining defensible space or home-safety measures against wind-blown embers). In some cases, these discounts can be combined. Because discounts and eligibility differ by company, we urge you to contact the insurance company directly to find out if your property qualifies.

How do we become a Firewise USA Community?

4 Steps

- 1. Organize
- 2. Plan
- 3. Do
- 4. Apply





How do we become a Firewise USA Community?

1. Organize

- Form a board/committee comprised of residents
- Loop in VCFD, County Supervisor, Ventura Regional Fire Safe Council
- This group will determine exact site boundary and size

(minimum 8 homes and maximum 2500 homes)

• VRFSC Lead Wildfire Safety Liaison (Max Young) can assist with this!

How do we become a Firewise USA Community?

2. Plan

- Obtain a Wildfire Risk Assessment (WRA) for the site
 Ventura County Fire Department can assist
- The Wildfire Risk Assessment summarizes current conditions, and identifies goals and areas of improvement within the community
- Board/Committee will use WRA to develop a 3-year Action Plan
- The AP list will prioritize projects and investments to reduce risk
- AP will also suggest homeowner actions and education activities





What does a Wildfire Risk Assessment entail?

- Collaboration with VCFD to document and summarize general conditions
- Vulnerability of homes to ember, surface fire, and crown fire
- Immediate hazards within home and ignition zones
- Concerns presented in common/open space and public lands
- General structural characteristics (roofing, siding, decks)
- Vegetation types and conditions (live/dead)
- Topography, wind exposures, and history of wildfire
- Prioritized recommendations based on the potential fire threat to homes





How do we become a Firewise USA Community?

3. Do

- Host an outreach event and work with neighbors on addressing action plan items
- Utilize direct mailers, Facebook, Nextdoor, email lists (HOAs & others)
- All efforts will go towards site's annual wildfire risk reduction investment
- All volunteer hours and efforts, down to the homeowner level, are tracked
- Each community is required to annually invest 1 volunteer hour (or its equivalent) per dwelling unit in wildfire risk reduction actions





How do we become a Firewise USA Community?

3. Do (cont.)

- Community Education 1 activity / year
- Homeowner Volunteer Hours 1 hour / household*
- Report quantity of vegetation removed (no minimum)**

* Elaboration of volunteer hours in the non-profit world needed - (weed abatement and meeting hours count)

** Elaboration of vegetation units needed





How do we become a Firewise USA Community?

4. Apply

Yes, Steps 1 – 3 must be completed before Recognition can be achieved

- Submit application online at portal.firewise.org
- Firewise USA approves all applications for the initial and subsequent Firewise Certificate of Recognition requests





How do we maintain our Certificate of Recognition?

- **Annual**: record and report education activities, volunteer hours and vegetation removed
- Every 3 years: update Action Plan
- Every 5 years: obtain new Risk Assessment
