Ventura County Sheriff's Department, CHP, Oxnard PD

towed two cars. VCSO update by Officer Collins and Captain Gibson. Recent shooting occurred last week in El Rio on Balboa & Cortez, and they are asking the public for help on information or details regarding the incident. Mentioned the Homeless Liaison Unit (HLU) which will be fully staffed in October. As Halloween approaches, parents should be having conversations with their children about the importance of safety and costumes. Also mentioned the Statewide issue regarding school threats and assured their offices are taking each threat seriously and are fully investigated. Ariana Castellanos-Rodriguez from Supervisors Long's office informed the MAC on updates in the community. PWA went out and painted red curbs on the entrance of Central Ave and Strickland Ave on both sides of the street to assist with congestion issues. The office was notified of faded red curbs in front of Rio Plaza Elementary School and PWA repainted them and repaired a damaged bench at the bus stop in front of the school on Simon Way. As mentioned by CHP and Sheriffs, they have tagged, ticketed, and towed vehicles that have been parked for long periods of time between Central Ave & 118. Gave an update on the El Rio Pedestrian Project and the community center on behalf of Public Works and Parks.

Tim Furgal from VC Library's gave some updates and shared dates to upcoming events. Also mentioned that the mobile library comes to Nyeland Acres each month on the third Wednesday.

Sherry Leal-Ryan, supervisor of the Albert H. Soliz Library in El Rio shared that they are offering homework help now that school has started for K-8th students.

A member of the public mentioned creating a non-profit for the El Rio community. Monique Garcia with the Boys and Girls Club of Nyeland Acres gave an update on the things they have been doing such kindness ambassadors, soccer academy, junior entrepreneurship, and a student from the Nyeland Acres community up for a \$10,000 scholarship opportunity for the National Youth of the Year.

Oscar Hernandez with the Rio School District mentioned their after-school programs that approx. 1,000 students attend, held two movie nights in Nyeland Acres, and new fencing that is going up.

Mary Anne Rooney with the Nyeland Promise gave an update on the things they have been doing like ESL classes, community clean ups, and murals. She also spoke about what a MAC is for and to disband the facility district in Nyeland Acres.
