## VII. Council Member Comments

Lorain Bailon is concerned about the Adjudication letter and wanted more information regarding the Lawsuit involving Fox Canyon, United Water, and the City of Oxnard. She also wanted to know if each water mutual will respond to Adjudication letter and if they will need to get their own attorneys?

Mary Anne Rooney explained that if you have a water well you should contact an attorney regarding your water rights, if you are under the City of Oxnard or a Water Mutual, they will take care of it.

## **Updates by Supervisor Kelly Long, Third District**

VIII. Supervisor Kelly Long opened by presenting Ken Knudsen with a Certificate of Appreciation for his time and service to the El Rio Del Norte MAC.

She also had the oppurtunity to highlight Yvonne Becerra, Supervising Library technichian for her amazing job bringing Actor Danny Trejo to the El Rio Library to share his motivating life story to the 400 attendees.

Supervisor Long updated the MAC to the upcoming changes surrounding the Nyeland Acres Community Center and Park that will be presented at the Board of Supervisors meeting on June 27, 2023.

The Board of Supervisors will be voting to suspend the Community Facilities parcel tax and add the Nyeland Community Center to the County Parks System, allowing the park to be open to the community from dusk till dawn on a daily basis.

The yearly parcel tax will be removed from Nyeland Acres property owners annual proprty tax bill.

The old Community Center will be demolished, and a new larger Community Center will be built in its place using American Recovery Plan Act (ARPA) funds as well as state funding. Supervisor Long advised to be on the lookout for community input opportunities as the County moves forward with the project.

- Q. Mike Barber, when will the mobile library be open to the community?
- A. Michael Inda, Currently working with the Director Library Services Nancy Schram and The Boys and Girls Club to set a schedule date.
- Q. Brenda Heredia, will the park have bathrooms in future?
- A. Supervisor Long, No it is not common for neighborhood parks to have restrooms.

- Q. Brenda Heredia, Will the playground be open to the community?
- A. Supervisor Long, Yes the park and playground will be open dusk till dawn on a daily basis.
- Q. Ayxa, will the soccer goals be replaced so that my brother, sister and the kids in the community can play soccer?
- A. Supervisor Long, When the new community center is built the County will look into getting equipment that will be long term based on the information gathered from the community engagement. The Boys and Girls Club removed the goals for liability reasons.
- Q. Mike Barber, Six years ago the communty raised funds and donated the soccer goals. The bolts were missing and not put together properly.
- A. Michael Inda, After speaking to CEO, Erin Antrim she stated one of the goals was missing an arm and could really injure someone. For liability reasons they were removed.
