#### VI. Council Member Comments

Lorane Bailon— confirm that emails were sent to public safety regarding the March 21, 2024 MAC meeting. She stated that the MAC needs public safety representatives at every meeting. Lorane also stated that she didn't receive an email with the agenda. Visibility of meetings. Requested that Supervisor Long Office create a MAC meeting flyer similar to one created by Supervisor Gorrell's office. Manuel Minjares replied that due to being short one staff member, a flyer will not be created by the next scheduled meeting. Manuel asked if any member of the board would be willing to work on this flyer. No MAC board member volunteered to work on the flyer.

#### **Business Items**

#### VII. Graffiti in El Rio – specifically on the main entrance of Simon Way

Lorane Bailon – graffiti on large white wall in El Rio, at main entrance to Simon Way, off of Rose Ave. This area should be a welcoming place. There used to be a graffiti removal program. Graffiti is an eyesore to the community.

Maryanne Rooney recommended that the graffiti removal program be brought back.

Brenda Heredia motioned for the graffiti removal program should be placed on the April MAC agenda for discussion. Mike Barber seconded Brenda's motion. MAC voted unanimously on Brenda's motion.

#### VIII. Rose Avenue walking path – unsafe conditions

Lorane Bailon – there is no sidewalk from Simon Way to Rose Ave and is not safe for pedestrians, including kids walking to and from school. Request that Public Works Streets and Roads Director Anitha Balan be present at May MAC meeting to provide an update on public works projects in the area and also to answer questions from the MAC and the community.

#### IX. Need for sidewalk – Simon Way to Rose Avenue

Aaron Wedemeyer made a motion to request a study on Simon Way to Rose Avenue. David Souza seconded the motion. Motion passed unanimously.

#### X. Code Enforcement issue – 3380 E Vineyard Ave – Parking of Semi-trucks lot

Bonnie Bernal – issue with semi-trucks parking on Simon Way and Vineyard and in supermarket parking lot obstructing views of traffic causing unsafe driving conditions. Request for code enforcement to look into the issue.

There is also an issue with semi-trucks parking in residential areas. Need for signage limiting vehicles by weight. Concerned with damage to streets and overhead utility lines. Speeding on Stroube is also an issue.

Mike Barber – county says no too much and suggestions fall on deaf ears. David Souza – signs get knocked down and don't get replaced.

Aaron Wedemeyer – Port Hueneme has not observed an increase to crime since it allowed for the retail sale of Cannabis, contrary to popular belief.
