### V. Summary: Approve Summary for October 9, 2017 meeting.

After due consideration, a motion to approve the October 9, 2017 meeting summary was made by Councilmember Ramirez and seconded by Chair Barber. The motion was carried by unanimous vote.

## VI. Public Safety Update

Officer Denharder, CHP shared the results of recent crosswalk and school bus "sting" operations done in the area, one specifically at Walnut and Alvarado. 60 enforcement stops were made. Most people received verbal or written warnings. On behalf of the Sheriff's office, Denharder shared there has been several recent thefts at the fields/farms in the area. Chair Barber asked if anyone had questions for the officer. Regarding the crosswalk sting etc. Councilmember Knudsen said it would be a good idea to educate the kids walking to and from school as well. Officer Denharder said CHP does visit the schools and provide that education to the students. A member of the public asked if the school bus is stopped with its stop signs out are people driving on the opposite side of the road required to stop if there is a median separating the lanes. No, not if there is a median. However, if there is No median, yes, both directions of traffic are required to stop.

1. <u>Action:</u> Receive Presentation from Ventura County Animal Services
Randy Friedman, VCAS gave a presentation on the services and
responsibilities of Ventura County Animal Services, followed by question and
answer.

Randy Friedman gave a presentation on the services and responsibilities of Ventura County Animal Services. Chair Barber asked the Council if they had questions. Councilmember Bernal asked if VCAS accepts donations of pet food. Yes however, the food is put into a pet pantry to help pet owners since the dogs in VCAS care need to eat a consistent monitored diet. Chair Barber said he recently visited the shelter and it was very congested in the lobby area. Friedman agreed and explained this was due to a temporary closure of an entrance/exit. This is no longer a problem, the issue has been resolved. A member of the public, Jim Hupp asked if they euthanize bully breeds. No, not because of the breed alone, if an animal is euthanized it is for legitimate reasons other than breed. Councilmember Bernal asked about the re-release of trapped feral cats. Friedman said they no longer euthanize these animals they have found it is better to return and release them to the location they were trapped for reasons regarding territory etc. Vice Chair Souza asked what about if you find an animal or need to bring in an animal or have one picked up after hours. Friedman said shelter staff works until midnight and beyond that they have a call center to take calls and if need be they can dispatch a staff member out into the field.
