## **Addressing Homelessness - Point in Time Count**

Every year thousands of volunteers turn out nationwide to conduct an annual Point in Time Count and survey of people experiencing homelessness. On January 22nd, I joined other volunteers to survey and count those in our community who are living unsheltered or in places not meant for human habitation. The Point in Time Count is one piece of a concerted effort by the County to end homelessness in our communities. By participating in the Count, the County becomes eligible for federal funding



and grants that help provide shelter, services, and build housing. Thank you to the hundreds of local volunteers who participated in this year's count and the many organizations working to end homelessness in our County.

#### 2024: A Look Back

#### **Your County At Work**

One thing is clear: The County of Ventura is at work – investing in our region, providing excellent services, and improving infrastructure. The County's first responders – fire and law enforcement –ensure our communities are safe and that we can move forward in a way that will help families thrive. There are thousands of County employees who make the County function on a daily basis, and it is their work that makes it possible to serve the people of the Fifth District. In the last year:

- The County continued to invest in **affordable housing**, adding to the over \$124 million directed toward projects in the last four years. In 2024 alone, 408 new housing units were added in the Fifth District.
- The County continued investing in the **maintenance of our roads**; County Public Works has prioritized parts of Fifth Street (West), Hueneme Road, Rice Road, Doris Avenue, and Patterson Road for re-pavement. In recent months, the County Board of Supervisors approved \$6.8 million for intersection improvements, including intersections on Hueneme, Lewis, and Rice Roads.
- Construction continued at the Carmen Ramirez Family Justice Center (FJC) in Oxnard following investments from the County, state and federal elected officials; the FJC will serve survivors of domestic violence, assault, abuse and other crimes.
- Repair work at the **Ray D. Prueter Library in Port Hueneme** neared completion, improvements to **Kiddie Beach at the Channel Islands Harbor** were made, and soil piles near the **Oxnard Airport** were removed.

## 2024: A Look Back, Continued

#### **Establishing Fifth District Youth Council**

#### **Recognizing our Friends and Neighbors**

There are many accomplishments and milestones that we celebrated across our district. At our Board meetings, I brought forward proclamations to recognize **Pride Month**, **Juneteenth**, and **Indigenous People's Day** among others. In 2024, I also brought before the Board:

- three classes of graduates from the 'La Tierra Donde Sembramos' program a
  program designed to empower our indigenous migrant community through a training
  and certification program aimed at advancing career building skills and increasing job
  opportunities.
- 200 student volunteers from the **Westminster Free Clinic** who participate in a rigorous two-year program that builds excellent job skills in the health care profession by assisting volunteer medical professionals in the delivery of primary health services to over 12,000 low-income uninsured residents at two locations in Ventura County.
- the team at **Swap Meet Justice** who provided the Board a report on their monthly programming. Funding for Spanish and Mixteco interpreters have helped community members connect with services.

## **Sending Donations to Ocotlan**

Also in 2024, I led efforts at the Board to approve a donation of public safety equipment no longer used from the Ventura County Fire and Sheriff departments to the City of Ocotlan, Jalisco, Mexico in partnership with the Oxnard Sister City Committee. The walkie talkies, vehicle radios, and fire fighting equipment will provide a long-lasting public benefit to our sister community for years to come.
