

ORDER OF THE BOARD OF SUPERVISORS  
ADOPTING A NEW SEAL OF THE BOARD OF SUPERVISORS  
AND AS THE SEAL OF VENTURA COUNTY

It appearing to the Board of Supervisors to be in the public interest of the County of Ventura to adopt a new seal that clearly depicts and is representative of the historical founding as well as the modern economy of said county, it is therefore ordered that effective January 1, 1965, said Board of Supervisors adopts the attached renditions as the Seal of the Board of Supervisors and as the Seal of Ventura County. Said seal of the Board of Supervisors shall be 2½" in diameter.

It is further ordered and directed that a description and impression of said Seal shall be filed in the office of the County Clerk and the Secretary of State.

It is further ordered and directed that said seal shall be in the custody of the County Clerk and ex-Officio Clerk of the Board of Supervisors and shall be impressed, printed or stamped when necessary to attest the execution of acts and documents of said Board of Supervisors.

It is further ordered and directed that said Seal of the Board of Supervisors and Seal of Ventura County shall be the seal that is affixed to County vehicles, business cards, letterheads, and in such other manner as appropriate, but that no effort be made to replace the seal on vehicles, business cards, letterheads, etc., except through a normal replacement basis.
