## Conflict of Interest & Statements of Economic Interests (Form-700)

As a requirement of your appointment, you must submit the Statement of Economic Interests Form-700 in a timely manner.

The Political Reform Act of 1974 (Government Code Sections 81000, et seq.), which was approved by the voters of the State of California, is intended to prevent conflicts of interest by requiring public officials to disclose certain personal financial interests, which could foreseeably cause conflicts. In addition, a public official may be required to disqualify himself/herself from making, participating in, or attempting to influence any government decision that will affect any of his/her financial interests, not just those that are required to be disclosed.

# Boards, Commissions, and Committees

### Community Participation in Local Government

Community participation and involvement are strongly encouraged by the County of Ventura Board of Supervisors who appoint community members to various Boards, Commissions, and Committees.

#### **Recruitments**

Recruitments are ongoing to fill any vacancies throughout the year and to fill positions on a newly created board, commission, or committee or to provide sufficient members on a board, commission, or committee for a quorum.

As part of the recruitment process, the Clerk of the Board Office shall maintain information about each Board, Commission, and Committee that is created by the Board of Supervisors (Board). The Board Office or County Department shall review the applications and interview the applicants prior to recommending the appointment to the Board of Supervisors. In some cases, a panel may be created to review the applications.

#### Eligibility

Qualifications for membership vary depending on the Board, Commission, or Committee. Appointees must be a United States citizen, 18 years of age or older, and living within the County of Ventura. In some instances, the applicant must be able to meet minimum qualifications specific to the board in which you are applying.

Membership qualifications are listed in the vacancy notice available in the County of Ventura, Clerk of the Board office, at the main Library, and on the County's website at <a href="mailto:ventura.org/ceo/cob/bcc">ventura.org/ceo/cob/bcc</a>

#### **Application Process**

Persons interested in serving on a County of Ventura, Board, Commission, or Committee, including incumbents who wish to be considered for reappointment, must file a separate application for each board with the Clerk of the Board's Office. The application consists of three pages,

however, you may also submit supplemental information.

Applications may be completed for vacancies that currently exist or for consideration when future scheduled or unscheduled vacancies occur. An application remains on file in the Clerk of the Board Office for a period of one year from the date of receipt unless the applicant requests that it be withdrawn.
