# 2014 REVISED CONFLICT OF INTEREST CODE FOR COUNTY OF VENTURA CIVIL SERVICE COMMISSION

The Political Reform Act, Government Code section 81000 et seq., requires local government agencies to adopt and promulgate Conflict of Interest Codes. The Fair Political Practices Commission has adopted a regulation (Cal. Code Regs., title 2, § 18730) which contains the terms of a standard Conflict of Interest Code, which may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act after public notice and hearings.

The terms of California Code of Regulations, title 2, section 18730, and any amendment to it duly adopted by the Fair Political Practices Commission, are hereby incorporated by reference as the Conflict of Interest Code for this agency and, along with attached Exhibit A, in which officials and employees are designated, and attached Exhibit B, in which disclosure categories are set forth, constitute the Conflict of Interest Code of this agency.

Pursuant to section (b)(4) of the standard code, the Filing Officer for statements of economic interest shall be the Clerk of the Ventura County Board of Supervisors.

#### **Disclosure Categories**

Subject to the definitions in the Political Reform Act and applicable regulations:

#### Category 1

All investments and business positions in any business entity, and income from any source, of the type which appears as (a) a party, (b) representative of a party, or (c) expert witness before the Civil Service Commission in any proceedings it may conduct, or that might reasonably be expected to appear in any such capacity in any such proceedings. By way of example, but without limitation, subcategory (a) would include employees within a bargaining unit with respect to which the Civil Service Commission has jurisdiction in connection with disciplinary appeals, subcategory (b) would include attorneys or law firms, as well as any union that represents or has represented employees in any proceedings before the Civil Service commission, and subcategory (c) would include physicians, accountants and other professionals who have served or might serve as expert witnesses in proceedings before the Civil Service Commission.

#### Category 2

All investments and business positions in any business entity, and income from any source, which provides services, supplies, materials, machinery or equipment to, or of the type utilized by, the Civil Service Commission.

#### Category 3

All investments, business positions or associations, and income (including gifts, loans, and travel payments) from persons or entities whose employment or whose clients' employment are subject to review by, or have or have previously had any matter pending before, the Civil Service Commission.
