AMENDMENT TO THE MEMORANDUM OF AGREEMENT BETWEEN THE COUNTY OF VENTURA AND THE VENTURA COUNTY PROFESSIONAL FIREFIGHTERS' ASSOCIATION

There is presently in full force and effect a Memorandum of Agreement ("MOA") between the Ventura County Fire Protection District ("District") and the Ventura County Professional Firefighters' Association ("VCPFA") which sets forth the terms and conditions of employment of all employees of the District represented by VCPFA through July 31, 2024.

The District and VCPFA have agreed to amend the 2021-2024 MOA as follows:

- Revise Article 13, Section 1302, "Combined Leave for Fire Unit Employees," as follows:
- Sec. 1302 (A) For historical purposes, for line assigned employees, the following holidays have been included in the Combined Leave accrual rates and shall be scheduled off in accordance with the above paragraph:
 - 1. New Year's Day, January 1
 - 2. Martin Luther King Day, 3rd Monday in January
 - 3. Presidents' Day, 3rd Monday in February
 - 4. Memorial Day, last Monday in May
 - 5. Juneteenth, June 19
 - **<u>5</u> 6**. Independence Day, July 4th
 - 6 7. Labor Day, 1st Monday in September
 - **7 8**. Admissions Day, September 9th
 - **8** 9. Veteran's Day, November 11.
 - **9**<u>10</u>. Thanksgiving Day, the fourth Thursday in November.
 - 10 11. Day After Thanksgiving;
 - 11 12. Christmas Day, December 25.
 - **12**<u>13</u>. And every day appointed by the Governor of the State of California for public fast, thanksgiving, or holiday when specifically approved by the Board of Directors will add an additional eleven and two-tenths (11.2) hours to each line-assigned, fifty-six (56) hour work week employee's Combined Leave bank.
- Sec. 1303 <u>ACCRUAL</u>: Annual Combined Leave periods are earned according to consecutive biweeks of full-time service, commencing with the employee's initial hire date, or with the first date of hire of his latest period of District or County employment.

Revise Article 38, Section 3802, "Holidays for Auxiliary Unit Employees," as follows:

 - 3. Presidents' Day, 3rd Monday in February
 - 4. Memorial Day, last Monday in May
 - 5. Juneteenth, June 19
 - 5 <u>6</u>. Independence Day, July 4th
 - 6 7. Labor Day, 1st Monday in September
 - **7**<u>8</u>. Veteran's Day, November 11.
 - 8 9. Thanksgiving Day, the fourth Thursday in November.
 - 9 10. Day After Thanksgiving;
 - 10 11. Christmas Day, December 25.
 - **11**<u>12</u>. And every day appointed by the President of the United States or Governor of the State for public fast, Thanksgiving, or holiday, when specifically authorized by the Board of Directors.
