### 401(k) Day – September 8, 2023

National 401(k) Day is September 8, 2023. It is estimated that 79% of Americans work for an employer that offers a 401(k) plan, however, only 41% take advantage of the benefit. The County of Ventura offers a 401(k) plan to full-time, regular employees with a regular work schedule of at least 40 hours per pay period and to regular UAPD members regardless of work schedule. National 401(k) Day serves as a reminder to review your contribution election. Are you contributing enough to get the full match that is available to you? To check on the matching table for your





bargaining unit, take a look at the <u>Plan Year Brochure</u>. It's easy to review your 401(k) contribution amount, just log into your Fidelity <u>NetBenefits</u> account.

#### **Retirement Planning 101 Workshop**

A successful retirement does not happen by accident. It takes planning and preparation, in addition to hopes and dreams.

To assist you in creating a plan for retirement, Deferred Compensation is partnering with the Ventura County Employees' Retirement Association, Fidelity Investments, County of Ventura Human Resources-Benefits, the Social Security Administration, and the Ventura County Area Agency on Aging to present a comprehensive preretirement planning workshop.



The *Retirement Planning 101: What You Need to Know* workshop is recommended for County employees who are **5-7 years from retirement**. The workshop is scheduled for Friday, September 15, from 8:30 a.m. - 1:30 p.m. Spouses/domestic partners are welcome to attend. Registration is required for both employee and spouse/domestic partner. #### Summer is a Great Time to Get Healthy

There are many benefits to getting outside. Research shows that the time we spend outside can have a very beneficial impact on our mental health. Researchers from Arizona State University found that setting aside just 20 minutes a day to stroll outside and get some sun exposure or sit in a place that puts you in contact with some aspect of nature can significantly lower your stress hormone levels. Other benefits associated with being outside in green spaces include: lower risk of depression and faster psychological stress recovery. Studies have shown that being in nature can restore and strengthen our mental capacities, increasing focus and attention.

## Safety Data Sheets and Chemicals in the Workplace

California employers are required to communicate any hazards associated with chemicals used or stored in the workplace to employees. This requirement is met by maintaining a safety data sheet (SDS) for each of these chemicals.

An SDS is a written document concerning a hazardous chemical that is prepared and provided by the product manufacturer. An SDS contains valuable information regarding the identified chemical hazards, ingredient information, first-aid measures required to treat exposure, fire-fighting measures, handling/storage requirements, disposal and transportation considerations, and more. SDSs must be readily accessible to employees, therefore most County SDSs are stored online. MSDSOnline is a web-based electronic database that keeps each SDS automatically updated and allows employees to search for and add items utilized in their workplace.
