Your Estate Planning Documents

Last Will and Testament of John Doe

I, John Doe, being of sound mind, hereby declare that this Last Will and Testament (this “Will”) is my will. I revoke all wills and codicils I have previously made.

Section 1: Place of Residence

I am a resident of the State of New Jersey.

Section 2: Marital Status

I am married to Jane Doe.

Section 3: Children

I have the following child now living: Julia Doe. For the purposes of this Will, any reference to my child includes Julia Doe, as well as any child of mine born or adopted after the execution of this Will; and any bequests contingent upon my child not surviving me shall also be contingent upon any other such child not surviving me.

Section 4: Guardianship of My Children

If a guardian is needed to care for any child of mine or a child's property, I name Lisa Jay to serve as guardian.
