


CALIFORNIA JURIES, PART 1

"Petit" juries (French for "small")

- 12 members chosen by random selection (jury of peers)
- Decide guilt, innocence, or liability





WHAT IS THE CIVIL GRAND JURY?


- A volunteer group that investigates whether local government is:
- Serving the best interests of residents
- Applying the law fairly
- Using our resources wisely



WHAT WE MAY INVESTIGATE (1)

- VENTURA COUNTY GOVERNMENT, its departments and processes
- CITY GOVERNMENTS and their agencies, processes, and contracts
- ALL UNINCORPORATED AREAS (not within city boundaries)

WHAT WE MAY INVESTIGATE (2)



• AGENCIES & SPECIAL DISTRICTS (Examples) **School Districts Fire District Airports Harbor Districts** Water Districts **Sanitation Districts Air Pollution Control District Health Care Agency Animal Services**



AUTHORITY OF THE GRAND JURY


- Inspect and audit books, records, and expenditures
- Inspect conditions of detention centers and jails
- Investigate complaints of government mismanagement or inefficiency
- Investigate charges of misconduct or unfair treatment by public officials or employees



INVESTIGATIONS

Usually originate in response to a public complaint (complainant's identity kept secret)

May originate within the Grand Jury itself



Publicly available reports

CIVIL OVERSIGHT PROCESS

Attend briefings by local government officials

Visit selected county and city facilities

Identify processes/facilities to investigate

Conduct independent research/interviews

Write reports with recommendations

Follow up on changes

QUALIFICATIONS FOR **GRAND JURORS**

- U.S. citizen 18 years of age or older
- Resident of Ventura County for at least one year immediately before serving
- Average intelligence and good character
- Sufficient knowledge of English

COMMITMENT

Grand jurors serve a oneyear term (July 1 - June 30). They may serve up to 35 hours a week Monday through Friday.

With advance notice, vacations or single days off can be taken at any time.



STIPEND AND REIMBURSEMENT

Grand Jurors receive a stipend based on actual days served. The current rate is **\$25 per day plus mileage**. Mileage is reimbursed according to the current established IRS rate.



TIMEFRAMES (1)

January – Mid April

- Applications accepted from the public.
- ✓ Grand Jury conducts an open house.

May – June

- ✓ Applications are reviewed.
- ✓ Selected applicants are invited for interviews.

TIMEFRAMES (2)

June

- Prospective jury of 30 is named consisting of:
 - Up to 10 "holdover" members from prior jury;
 - New applicants.
- Mandatory orientation program is conducted for prospective jurors.
- Past year's final investigative reports are issued and made public by June 30.

TIMEFRAMES (3)

July 1

A random drawing of new applicants is conducted to complete the 19-member Grand Jury.



 New Grand Jury members are sworn in and start the same day.
