COMMUNITY RELATIONS

The committee is charged with increasing general knowledge about the duties and responsibilities of the Grand Jury, with a goal of broadening citizen participation in this body.

With that goal in mind, two open houses were held early in our term. Responding to our invitation, over 100 guests visited in the Grand Jury chambers, including county residents department and agency heads and representatives of the media.

Because of a general consensus that Ventura County citizens are unaware of Grand Jury activities, the committee initiated a random poll of county residents. The poll was designed to determine the extent of knowledge among the general populace regarding the Grand Jury. (Results of the poll were published through local newspapers).

A Speakers Bureau was established to address organizations in Ventura County. Speakers explained functions of the Grand Jury and encouraged the public to seek service on the panel. It was determined that only through public understanding can we maximize the effectiveness of Ventura County's Grand Jury system.

This committee receives and acts on all citizen complaints. Complaints must be in written form, signed, dated and include a valid return address and telephone number. Without this information, a complaint cannot be processed.

All complaints are reviewed and referred to the appropriate committee for action when necessary. Some complaints only require a letter of acknowledgment and explanation of why the complaint cannot be addressed by the Grand Jury. Others may evolve into a full investigation.

The 1997/98 Grand Jury received 86 complaints, 9 of these resulted in Final Reports.
