he Ventura County Grand Jury is an independent investigative body whose primary function is investigating and reporting on all governmental bodies within the county. Its powers and duties include bringing indictments for criminal or public offenses and being responsive to citizens' complaints.

The Grand Jury is directed to prepare and issue a final report in accordance with Penal Code Section 933 and must include suggested means for resolution of problems identified under Penal Code Section 916.

The 1998-1999 Grand Jury finds it interesting that we are still reviewing areas of the County Government that were reviewed 100 years ago!

Editor's note: This weekly column features excerpts from the forerunner of the Ventura County Star. Some excerpts might contain language that is considered offensive today, but is included for historical accuracy.

VENTURA FREE PRESS, FRIDAY, MARCH 24, 1899:

NEWS OF THE WEEK.From the Grand Jury Report.


We find that the Hospital is kept in a neat manner inside and out, and no complaints from inmates. The grounds, toilet rooms, stable and outside wards are all in good order and we recommend that a coat of good paint be applied to the front of the main building, put on by the day and not by contract as contract paint does not seem to be durable.

We find the county jail all right with a few exceptions. The prisoners seem to be well fed and taken care of, but we find it very cold in the iron tanks with no means provided for heating them. The Sheriff informs us that the water comes into the basement in front through the walls and floor when it rains. The wards for the insane prisoners are nicely padded and in good order.

The Court House we find in good order with a few exceptions, and we are gratified to say that the county officials are not inclined to ask for anything new this dry season, excepting on account of the ladies employed they suggest and we recommend that the toilet closet at the end of the stairs be prepared for the use of ladies exclusively, and that a sign be placed upon the door designating it as such.

Foreman's Statement

It has been a great honor and pleasure to serve as the foreman of the 1998-1999 Ventura County Grand Jury. I have been privileged to serve with eighteen dedicated, hardworking, intelligent and resourceful citizens of our county. The Grand Jury panel was composed of people of different ages, different educational and occupational experiences and different life experiences in general. This diversity has contributed greatly to the success of the panel.

In Ventura County, the Grand Jury has a dual responsibility. One area is dealing with the criminal investigative and indictment procedures. The other major area of responsibility deals with civil oversight. Most of our work during this term has been in this latter area.

The Grand Jury is designed to be a watchdog agency as well as the conscience of the community. Justice Louis Brandeis has said, "sunlight is the best antiseptic." It is in this spirit that this Grand Jury has spent a great deal of time and energy attempting to reflect sunlight into the dark crevices of governmental organizations within the county. It is with our legislated mandate in mind that we have sought to uncover any inefficiencies, malfeasance, or unethical behavior which may be present in the various governmental bodies within the county and if anything untoward is found, we have the responsibility to recommend corrective actions. I believe that, considering the constraints of time, personnel and funding, this Grand Jury has been very effective in carrying out this mandate.

Even though our county is a wonderful place to live, we have not yet arrived at a state of perfection. There is still much to be done. While honest people can certainly disagree with solutions to problems, one would be hard pressed not to agree that the problems, as outlined, do exist. Highlighted in this report are some of the problem areas uncovered as well as recommended solutions to these problems. While these may not be the only problems that exist nor the only solutions available to solve these problems, great significance can be attached to the fact that it is through the Grand Jury process and this report that these problems are exposed. The ultimate solution, in some cases, may be arrived at only through a consensus of the public at large.

I am pleased to report that, for the most part, we found that our county is staffed by hardworking, honest, dedicated individuals who, in some cases, are working under very difficult conditions. We did find that the complexity of county government, including the structure of the many special districts and commissions as well as the complexity of the budgeting process, serve to reduce the efficiency and cost effectiveness of county operations. These matters are addressed in greater detail elsewhere in this Grand Jury Report.

This Grand Jury has taken steps to update and improve the current Grand Jury manual as well as providing the incoming Grand Jury with a number of computer templates and forms, which should make their transition somewhat easier. Additionally, there are other areas of investigation that, due to a lack of time and resources, we were unable to pursue. We are hopeful that the incoming Grand Jury might examine some of them.



Areas of Interest /Sphere of Influence


