

Legal requirements for responses

Section 933.05 - Response to Finding

- (a) For purposes of subdivision (b) of Section 933, as to each grand jury finding, the responding person or entity shall indicate one of the following:
 - (1) The respondent agrees with the finding.
 - (2) The respondent disagrees wholly or partially with the finding, in which case the response shall specify the portion of the finding that is disputed and shall include an explanation of the reasons therefor.
- (b) For purposes of subdivision (b) of Section 933, as to each grand jury recommendation, the responding person or entity shall report one of the following actions:
 - (1) The recommendation has been implemented, with a summary regarding the implemented action.
 - (2) The recommendation has not yet been implemented, but will be implemented in the future, with a timeframe for implementation.
 - (3) The recommendation requires further analysis, with an explanation and the scope and parameters of an analysis or study, and a timeframe for the matter to be prepared for discussion by the officer or head of the agency or department being investigated or reviewed, including the governing body of the public agency when applicable. This timeframe shall not exceed six months from the date of publication of the grand jury report.
 - (4) The recommendation will not be implemented because it is not warranted or is not reasonable, with an explanation therefor.
- (c) However, if a finding or recommendation of the grand jury addresses budgetary or personnel matters of a county agency or department headed by an elected officer, both the agency or department head and the board of supervisors shall respond if requested by the grand jury, but the response of the board of supervisors shall address only those budgetary or personnel matters over which it has some decision making authority. The response of the elected agency or department head shall address all aspects of the findings or recommendations affecting his or her agency or department.
- (d) A grand jury may request a subject person or entity to come before the grand jury for the purpose of reading and discussing the findings of the grand jury report that relates to that person or entity in order to verify the accuracy of the findings prior to their release.
- (e) During an investigation, the grand jury shall meet with the subject of that investigation regarding the investigation, unless the court, either on its own determination or upon request of the foreperson of the grand jury, determines that such a meeting would be detrimental.
- (f) A grand jury shall provide to the affected agency a copy of the portion of the grand jury report relating to that person or entity two working days prior to its public release and after the approval of the presiding judge. No officer, agency, department, or governing body of a public agency shall disclose any contents of the report prior to the public release of the final report.

Foreman's Statement

feel very privileged to have been allowed to serve as the foreman of the 1999/2000 Grand Jury. I was honored by this appointment and I hope that my colleagues, the members of the court and the other citizens of the county feel that I have served them well.

During the past year, our county has been faced with many challenges. The grand jury, as it should, has continued to stay above the fray and look at all issues in a fair and unbiased manner.

If one were to study only the headlines and editorials of the past year, one would be led to believe that our county is in crisis. I believe that a careful analysis of all of the facts would lead one to a contrary belief. That is not to say that improvements could and should not be made. Changes and improvements should be made; however, they should be made in a thoughtful and insightful manner and not in a crisis mode.

It appears to me that there has been a great deal of confusion as to the source of the county's financial difficulties. I am sure that a good case can be made for all sides. There have been many accusations, condemnations and recriminations. There is surely enough blame to go around.

Instead of attempting to place blame, we should acknowledge that by and large our government is populated by very hardworking, dedicated, intelligent and honest individuals. It is because of these people, we have a county of which to be proud. Ours is a county government that, by and large, serves its citizens very well indeed and is certainly the envy of many in this nation.

The purpose of this statement is not to place blame on any person or group of people but rather to ask, on behalf of the citizens of this county, that no plan of such great magnitude be instituted in the future without a clear course of action. Such action might include a table of organization, a well thought out proposed budget, a detailed study of requirements for physical facilities and in

addition, there should be a complete study of the moral, ethical and legal ramifications of any such plan. Most importantly, there must be a greater consensus among our Supervisors.

In closing, let me state that there are a few areas in our county government that should be corrected. Some of these areas are discussed in our final report. These are areas in which dedicated people should be trained and supervised properly. More efficient and accurate systems should be put in place and steps should be taken to ensure that these procedures are followed. Let us not suffer from a "Chicken Little" syndrome. The sky is not falling! We do not, in fact, have a county in crises, but, rather, we have an outstanding county and a wonderful place to live that we should all strive to make even better.
