Response to the 2003-2004 Ventura County Grand Jury Report entitled *Public Records Act Implementation* 

Dear Honorable Judge Clark:

Pursuant to Penal Code Section 933(c), this letter serves as the City of Fillmore's response to the finding and recommendations found in the above-referenced report.

The City fully concurs with the findings contained in the report, with the exception of Finding F-24. F-24 states "Most cities report that all requests are treated as requests under the Act even though the request does not mention the Act. Fillmore did not respond to that question." The City disagrees with this finding as the City did provide an answer on this per Question No. 12. For Question No. 12, City staff checked the "No" box in response to the question. Therefore, an answer was provided by the City of Fillmore. A copy of the response provided by the City for Question No. 12 is attached.

The City is required to respond to Recommendation No. 4 in the report, which states: "The mayor or city manager of each of the cities of Camarillo, Fillmore, Moorpark, Port Hueneme and Santa Paula should develop and publish, or review and update, a policy manual addressing implementation of the Public Records Act, with emphasis on proper fee charging, assistance in formulating the public record request, a requirement to maintain logs of requests for compliance audit, counsel review of any proposal to deny a request, timely responses to the requestor, and availability of administrative appeal." This recommendation will be implemented by the City of Fillmore within 90 days of the date of this letter.
