FINDINGS

The Santa Paula Elementary School District agrees with the findings numbered:

RECOMMENDATIONS

Recommendations numbered R-01, R-02, R-03 and R-04 have been implemented as follows:

R-01: The Santa Paula Elementary School Districts currently updates Earthquake Disaster Plan (EDP) and Comprehensive School Safety Plans (CSSP) annually. We will continue to review and update our (EDP) and (CSSP) annually, as required by the California Education Code.

R-02: The Santa Paula Elementary School Districts will continue to conduct safety drills and safety inspections on a regular basis.
