

Summary

The 2012 – 2013 Ventura County Grand Jury (Grand Jury) opened an inquiry into the methods and systems of the Moorpark College Associate of Science Degree in Nursing (ADN). This inquiry was conducted on the basis of public reports, various community interests and practices of the program.

The Moorpark Community College's (Moorpark) Registered Nursing (RN) program is a nationally accredited Associate Degree (AS) in Nursing Science. The program is accredited by the California State Board of Registered Nursing. This allows students to take/pass their state examination. Remarkably, the current passing rate of the State Board examination is 100%. The graduation rate for an AS degree is also 100% in this field of study. The Moorpark Nursing Program is accredited by the National League of Nursing Accrediting Commission (NLNAC). These facts led the Grand Jury to commend Moorpark College Associate of Science Degree in Nursing for the outstanding effort in advancing the study of nursing.

The Program's student success is attributed to the faculty dedication, student motivation and the benchmark assessments developed for this program. The educational goals are distinctive in that they afford each student the opportunity to track his or her success. The benchmarks are to:

- complete all science and math pre-requisites
- be admitted to the Moorpark Nursing Program
- successfully complete Nursing Science 1
- successfully complete Nursing Science 2
- successfully complete Nursing Science 3
- successfully complete Nursing Science 4
- have completed all general education requirements for an Associate of Science Degree
- pass the California State Board of Nursing examination

Background

Nursing is one of the top career choices in community colleges nationally, with high expectations of finding work after graduation and the ability to adjust schedules to meet family needs. Professional RNs are concerned with the promotion of health through client teaching and nursing care. The prevention of illness and client-centered care are the focus of nursing via independent and interdependent decision making in collaboration with the client/patient and other members of the healthcare team. The successful nurse has an interest in helping people, communicates effectively, possesses critical thinking and organizational skills, is flexible and has the ability to work cooperatively with other healthcare personnel.

The Associate Degree Nursing Program at Moorpark Community College has been approved by the California Board of Registered Nursing, and prepares students for entry into the practice of professional registered nursing. Students receive experience in a variety of clinical facilities and community agencies in Ventura County. The successful completion of this program can entitle the student to an Associate of Science Degree, and eligibility to take the professional licensing examination through the State of California to become an RN.

Employment opportunities are available in multiple healthcare settings such as surgical centers, doctors' offices, clinics, acute care hospitals, skilled nursing facilities, rehabilitation centers, home healthcare, outpatient settings and volunteer service agencies such as the Peace Corps, the military and other agencies.

Methodology

The Grand Jury reviewed numerous public records with respect to the various subjects of the study, as well as interviewed persons involved with the Moorpark College Nursing Program. The Grand Jury examined the practices and written policies of the RN program as well as public records. Also considered were current and historical documents related to the program's outcomes. In addition, the Grand Jury sought and received best practices information from impartial experts within the academic community and governance and used Internet sources for public records.

Facts

- **FA-01.** The Moorpark RN program is a nationally accredited Associate of Science Degree in Nursing (ADN). The nursing program is approved by the California State Board of Registered Nursing (BRN) and accredited by the National League of Nursing Accrediting Commission (NLNAC). [Ref-01-03]
- **FA-02.** The Moorpark RN program adheres to a self-care concept of nursing as it is consistent with the faculty's beliefs and serves as the unifying framework. [Ref-01-02]
- **FA-03.** Moorpark RN programs theoretical guidelines for student progression and evaluation are modeled after a concept of novice practitioner to expert. [Ref-01-02]
- **FA-04.** Health Sciences literacy and core competencies are identified as student expected competency. [Ref-01-02] (Att-01)
- **FA-05.** The nursing process is an organizing framework for nursing practice that includes: nursing assessment, nursing diagnoses, planning, writing outcome/goal statements, interventions, implementing care and evaluating care that has been given. [Ref-01-02] (Att-01)
- **FA-06.** The application process is recommended to begin with an appointment with a nursing counselor. [Ref-01-02]

- **FA-07.** Applications to the nursing program are accepted twice a year. [Ref-01-02] (Att:01)
- **FA-08.** The application procedure includes several different documents: application, checklist, supporting documents, if applicable, and official transcripts of academic coursework from high school, colleges, as well as the assessment/readiness test. [Ref-01-02]
- **FA-09.** Application requirements are: high school graduation or General Education Diploma (GED) with a score of 45 or passage of the California High School Proficiency Exam (CHSPE); minimum overall GPA of 2.5 or better; minimum core biology (anatomy, physiology, and microbiology) with a C or better, taken within five years of application; a grade of C or better in college intermediate algebra. [Ref-01-02]
- **FA-10.** Moorpark College ADN program admission criteria are required. [Ref-01-02] (Att-01)
- **FA-11.** All Moorpark ADN students are also required to take the Test of Essential Academic Skills version V (TEAS V) as part of the admission criteria. [Ref-01-02] (Att-01)
- **FA-12.** Remediation may be required as the result of a low score on the TEAS V test, a low score, or as a condition of possible readmission. [Ref-01-02]
- **FA-13.** An application is active for two years. If not admitted within two years of submitting an application, one will need to reapply. While waiting to reapply, there are required, recommended and strongly recommended activities. [Ref-01-02]
- **FA-14.** Out of 156 California State Universities, private universities and colleges and California Community Colleges that offer an ADN program, there are only 14 schools that have a 100% pass rate. [Att:02]

Findings

- **FI-01.** The Moorpark College Associate of Science Degree in Nursing has a 100% passing rate at the California State Board of Registered Nursing. It also enjoys a national accreditation through the National League of Nursing Accrediting Commission. (FA-01-13) (Att-02)
- **FI-02.** The Moorpark College Associate of Science Degree in Nursing enjoys a 100% graduation rate after students complete all RN course work, as well as the required general education courses. (FA-12–13)
- **FI-03.** The Moorpark ADN is one of the 14 schools that have a 100% pass rate out of the 156 nursing programs statewide. (FA-14) [Att-02]



An organizing framework for professional nursing practice. Components of the process include performing a nursing assessment, making nursing diagnoses, planning, writing outcome/goal statements, determining appropriate nursing interventions, implementing care, and evaluating the nursing care that has been given.

- Assessment and nursing diagnosis identify the client's universal and developmental self-care demands and health deviations.
- Establishment of client outcomes/goals aim to prevent illness, meet the client's self care demand, restore health, move the client toward independent self-care or adaptation to self-care interruptions/decline, and transfer responsibility to family or significant others within the community setting.
- Implementation of nursing interventions can be preventive (educative/supportive) or restorative (wholly/partially compensatory).
- Evaluation of outcomes determines if the goals have been met; if not, the nursing process is begun again, starting with assessment.

I've been accepted to the program, but due to extenuating circumstances, I can't enter the nursing program at this time. Can I defer until the following semester?

Yes, a student who is accepted to the nursing program may defer entry one time, for up to a year, but only due to extenuating circumstances. You will not be allowed to defer because of incomplete remediation that was required of you. Request for deferral must be presented to the Health Sciences Department in writing, to the attention of the Health Sciences Coordinator.

I have my ADN already. Do you have any information about getting my BSN?

Yes, Moorpark College works closely with California State University Channel Islands (CSUCI), and encourages students to continue their formal education after obtaining their ADN. CSUCI offers two ADN to BSN options. 
